NOTICE: The health and well-being of National City residents, visitors, and employees during the COVID-19 outbreak remains our top priority. ORDER OF BUSINESS: Public sessions of all Regular Meetings of the City Council / Community Development Commission - Housing Authority (hereafter referred to as Elected Body) begin at 6:00 p.m. on the first and third Tuesday of each month. Public Hearings begin at 6:00 p.m. unless otherwise noted. Closed Meetings begin in Open Session at 5:00 p.m. or such other time as noted, and after announcing closed session items, convenes into a Closed Meeting. If a workshop is scheduled, the subject and time of the workshop will appear on the agenda. The Mayor and Council members also sit as the Chairperson and Members of the Board of the Community Development Commission (CDC).

REPORTS: All open session agenda items and reports as well as all documents and writings distributed to the Elected Body less than 72 hours prior to the meeting, are available for review on the City's website at www.nationalcityca.gov. Regular Meetings of the Elected Body are webcast and archived on the City's website at www.nationalcityca.gov.

PUBLIC COMMENTS: There are multiple ways you can make sure your opinions are heard and considered by our City Council as outlined below:

Public comments or testimony is limited to up to three (3) minutes. If the comment is not related to a specific agenda item,

indicate General Public Comment in the subject line. All email comments received by 4:00 p.m. on the day of the meeting will be read into the record at the City Council meeting, emailed to the City Councilmembers, and retained as part of the official record. All comments will be available on the City website within 48 hours following the meeting.

EXPLANATION:

December 21, 2021, the City Council adopted Resolution No. 2021-201, declaring its Intention to Transition from At-Large Elections for City Council to District-Based Elections for City Council pursuant to Elections Code Section 10010. Currently elected in "at-large" elections, in which the Mayor and each City Councilmember are elected by the registered voters of the entire City. District-Based would provide for a Councilmember to represent the voters in the district in which they reside and would be elected only by those voters within their district. The Mayor would remain at-large to represent the entire City.

The Statutory Process for moving to district-based elections requires at least four (4) public hearings. This will be the first required public hearing to consider moving to by-district elections. The City Council and public will receive a presentation by Matt Rexroad of Redistricting Insights, who has been hired by the City to assist with the demographic analysis. The presentation is an introduction to the districting process, the foundational legal principles involved, and the criteria used in developing district boundaries. All meetings will be held virtually and Public Comment will be received both written/verbal following the presentation.

AT LARGE VS DISTRICT ELECTIONS

At large elections: all candidates run on the same ballot and voters choose two or three representatives each election (current National City system).

<u>District elections:</u> the jurisdiction is split into separate geographic sub-areas where voters chose a dedicated representative for their area (future National City system).

WHY DISTRICT ELECTIONS?

- Geographic diversity: in a district-based election system, it is impossible for all board members to be from the same neighborhood.
- Minority representation: district-based elections allow greater opportunities for minority groups to select their candidate of choice.
- Lower barriers to entry: fewer voters selecting each member means it costs less to run a campaign.
- Closer to the people: in a district-based election system, each board member represents fewer constituents, which makes access to your representative easier.



CALIFORNIA VOTING RIGHTS ACT

The California Voting Rights Act empowers community members to take legal action if an electoral system dilutes the power of minority voters.

Courts have established that when racially polarized voting occurs, atlarge systems diminish the power of minority voters.

Racially polarized voting is when a racial minority group predominantly votes as a bloc for a preferred candidate of choice.

Racially polarized voting is common and not difficult to prove.

Thus, at-large election systems are a liability for jurisdictions.



WHAT IS REDISTRICTING?

Redistricting is at its core the act of equalizing population among districts.

Redistricting has changed significantly over the years as federal and state laws, norms, best practices, and public opinion has transformed.








EQUAL POPULATION


What is "equal" population has been a key subject in redistricting litigation.

- Population Equality is based on "People" not citizens or voters or other metrics.
- The metric used is called "deviation" which is a measure of how close a district is to equal size.

Equal Districts




EQUAL POPULATION


What is "equal" population has been a key subject in redistricting litigation.

- Equality is Required
- Strict adherence to a numeric goal for equality beyond what is required is not necessarily better.


Not Equal Districts





FEDERAL VOTING RIGHTS ACT











WHAT IS THE VOTING RIGHTS ACT?

The decision to invoke Section 2 is something that requires legal counsel.

Does the minority population qualify under Section 2?

Is the proposed district a sufficient remedy – is it an "effective" majority minority district?

Is there a claim for a coalition district?

Without Section 2, a community of interest can still be supported but race cannot be a predominant factor in drawing lines.

GINGLES FACTORS

"Gingles factors" are three preconditions that a minority group must meet to establish a violation of Section 2 of the Voting Rights Act. These preconditions are the following:

- 1.A minority group must be sufficiently large and geographically compact to comprise a majority of the district;
- 2. The minority group must be politically cohesive (it must demonstrate a pattern of voting for the same candidates, also known as "bloc voting"); and,
- 3. A majority of voters vote sufficiently as a bloc usually to defeat the minority group's preferred candidate.

BUT THE GINGLES FACTORS HAVE LIMITS.....



SHAW V. RENO, <u>509 U.S. 630</u> (1993)

SIGNIFICANCE: Legislative and congressional districts will be struck down by courts for violating the Equal Protection Clause if they cannot be explained on grounds other than race. While not dispositive, "bizarrely shaped" districts are strongly indicative of racial intent.

MILLER V. JOHNSON, <u>515 U.S. 900</u> (1995)

SIGNIFICANCE: A district becomes an unconstitutional racial gerrymander if race was the "predominant" factor in the drawing of its lines

COMMUNITIES OF INTEREST

Redistricting plans are built with census data to put communities of interest together to form districts.

When members of the public come forward to testify about their communities it can be almost anything.

Items to consider:

- What is the community of interest that is being described through the testimony?
- What is the geographic area of that community of interest?
- What data can be utilized to help identify that community of interest?
- How does that community of interest relate to National City?

COMPACTNESS

Many measures based on geography are available but in California we tend to adhere to


"shall be drawn to encourage geographical compactness in a manner that nearby areas of population are not bypassed in favor of more distant populations."

CONTIGUITY

This is not an issue in most cities... unless they have islands.

State law does not allow point contiguity...it is advisable to seek functional contiguity where you can travel through the district to each point.

WHAT IS REDISTRICTING?

Redistricting has changed significantly over the years as federal and state laws, norms, best practices, and public opinion has transformed.

In Public Opinion / Media:

- 97% of Voters agree that "local government should be required to have transparent / open redistricting."
- Media and Community Based Organizations have become much more adept at covering redistricting.

ONLINE MAPPING

There are other mapping tools the public may use, but are not controlled by the commission or city staff.

- These tools are perfectly
 appropriate for the community to
 use as input.
- Data and maps from these programs can be imported to our tools and reviewed by the commission.






NATIONAL CITY DEMOGRAPHIC ANALYSIS
