ORDER OF BUSINESS: Public sessions of all Regular Meetings of the City Council / Community Development Commission - Housing Authority (hereafter referred to as Elected Body) begin at 6:00 p.m. on the first and third Tuesday of each month. Public Hearings begin at 6:00 p.m. unless otherwise noted. Closed Meetings begin in Open Session at 5:00 p.m. or such other time as noted, and after announcing closed session items, convenes into a Closed Meeting. If a workshop is scheduled, the subject and time of the workshop will appear on the agenda. The Mayor and Council members also sit as the Chairperson and Members of the Board of the Community Development Commission (CDC).

REPORTS: All open session agenda items and reports as well as all documents and writings distributed to the Elected Body less than 72 hours prior to the meeting, are available for review on the City's website at <u>www.nationalcityca.gov</u>. Regular Meetings of the Elected Body are webcast and archived on the City's website at <u>www.nationalcityca.gov</u>.

PUBLIC COMMENTS: There are multiple ways you can make sure your opinions are heard and considered by our City Council as outlined below:

Submit your public comment prior to the meeting: To submit a comment in writing, email <u>PublicComment@nationalcityca.gov</u>, provide the agenda item number and title of the item in the subject line of your email. Public comments or testimony is limited to up to three (3) minutes. If the comment is not related to a specific agenda item,

indicate General Public Comment in the subject line. All email comments received by 7:30 a.m. on the day of the meeting will be emailed to the City Council Members and made a part of the official record.

Register online and participate in live public comment during the meeting: To provide live public comment during the meeting, you must pre-register on the City's website at <u>https://www.nationalcityca.gov/publiccomment</u> by 7:30 a.m. on the day of the regular meeting to join the City Council Meeting.

***Please note that you do not need to pre-register to watch the meeting online, but you must pre-register if you wish to speak.

Once registered, you will receive an email with a link from Zoom to join the live meeting. You can participate by phone or by computer. Please allow yourself time to log into Zoom before the start of the meeting to ensure you do not encounter any last-minute technical difficulties.

***Please note that members of the public will not be shown on video; they will be able to watch and listen and speak when called upon. Public microphones will be muted until it is your turn to comment.

Each speaker is allowed up to three (3) minutes to address the City Council. Please be aware that the Mayor may limit the comments' length due to the number of persons wishing to speak or if comments become repetitious or unrelated.

All comments are subject to the same rules as would otherwise govern speaker comments at the meeting. Speakers are asked to be respectful and courteous. Please address your comments to the City Council as a whole and avoid personal attacks against members of the public, City Council, and city staff.

Background

On December 21, 2021, the City Council voted to change the way the City Councilmembers are elected, transitioning to district based elections for the four City Councilmember seats. The Mayor would remain elected at-large. This transition requires that the City create districts and adopt a boundary map.

On Thursday, February 3, 2022, the City Council conducted the first required Public Hearing to provide information to the public on the districting process, the permissible criteria to be considered to draw district boundaries, and the process on how to submit draft maps for consideration, as well as to receive public comment. One verbal comment was received from Ken Seaton-Msemaji and three (3) written comments received from Rocina Lizarraga, Joan Rincon, and Evangline Meneses. In attendance were consultants from Redistricting Insights, SVPR Communications, and City staff. One member of the public registered for the meeting and attended via Zoom.

On Saturday, February 5, 2022, Community Workshop was held to provide information to the public on the process of creating districts for elections and the process on how to submit draft maps for consideration, as well as to receive public comment. The demographer provided an explanation on the districting process, and provided mapping tool training. Four (4) verbal comments were received from Cynthia Suero-Gabler, Gloria Cooper, Ken Seaton-Msemaji, and Mitz Lee. In addition, one (1) written comment was received from Thelma De Castro. In attendance were consultants from Redistricting Insights, SVPR Communications, and City staff. Five (5) members of the public registered for the meeting and attended via Zoom.

On Tuesday, February 22, 2022, the City Council conducted the second required Public Hearing accepting maps submitted for consideration. The demographer introduces the five (5) maps submitted and the public provided and presented a PowerPoint Presentation on the process. Cynthia Suero-Gabler representing the Asian Pacific American Coalition also provided a PowerPoint Presentation. Eight (8) verbal comments were received from Kandi Custodio-Tan, Alicia Sanchez, Monserrat Hernandez, Margarita Moreno, Silvia Calzada, JoAnn Fields, Ditas Yamane, and Ken Seato-Msemaji. In addition, nineteen (19) written comments were received from Kirin Macapugay, Thelma Virata de Castro, DJ Kuttin Kandi, Tony Olaes, Ted Godshalk, Nicole, Shawn Chua, Mark Leo, Czeska Cabuhat, Khue Tran, Marianne Delatorre, Andrew Amorao, Kristina Mananquil, Jose Ceja, Myleen Abuan, Alicia Ricafrente, Wendy Aragon-Mills, Salvador B. Flor, and Debbie Discar-Espe. In attendance were consultants from Redistricting Insights, SVPR Communications and City staff. Fifteen (15) members of the public registered for the meeting and attended via Zoom.

Twenty-Eight signed maps were received in support of the Asian Pacific American Coalition Proposed Map #1.

The four (4) districts must be drawn using the 2020 census data and in compliance with the FAIR MAPS Act (Act), which was adopted by the California Legislature as Assembly Bill 849 and took effect January 1, 2020.

Under the Act, the maps are drawn and adopt boundaries using the following criteria in the listed order of priority:

- 1. Comply with the federal requirements of equal population and the Voting Rights Act.
- 2. Geographically contiguous
- 3. Undivided neighborhoods and "communities of interest" (socio-economic geographic areas that should be kept together)
- 4. Easily identifiable boundaries
- 5. Compact (do not bypass one group of people to get a more distant group of people)
- 6. Shall not favor or discriminate against a political party.

The Statutory Process for moving to district-based elections requires at least four (4) public hearings. This will be the third required public hearing to consider moving to by-district elections. The City Council and public will receive a presentation by Matt Rexroad of Redistricting Insights, who has been hired by the City to assist with the demographic analysis. The presentation is an overview of the districting process, the

foundational legal principles involved, and the criteria used in developing district boundaries. All meetings will be held virtually and Public Comment will be received both written/verbal following the presentation.

The community is encouraged to participate in a series of five public meetings (see below for schedule), which will include four Public Hearings and one Community Workshop and Informational Session. Due to the COVID Pandemic all meetings will be held via Zoom. Staff has also created a District Elections webpage on the City website at <u>www.nationalcityca.gov/government/redistricting</u> to provide updated information throughout the process.

Community Outreach

The City has partnered with a consultant, Redistricting Insights, to utilize 2020 Federal Census data to determine district options for consideration. The City is working collaboratively with Falcon Strategies to engage the community and distribute information in multiple languages to ensure participation from all segments of the community.

To date outreach has included:

- 1. City Social Media (Facebook, Instagram, Twitter) and the City website (District Elections) page.
- 2. The City website page and social media includes translations of all documents in Spanish, and Tagalog.
- 3. Legal Noticing (English, Spanish, Tagalog) in The Star News, El Latino, and the Filipino Press. Also available on the City Bulletin Boards at City Hall and the City website Districting page.
- 4. Interviews with the City Clerk on Telemundo TV, NBC and CBS
- 5. Kiosks set up at the Library to assist with online mapping tool
- 6. Assistance at Library with the paper map drawing process
- 7. Livestreaming of public meetings on the City website and videos posted for future viewing.

The public is requested to continue to provide input regarding communities of interest and other local factors that should be considered while drafting district maps. A community of interest under the relevant Elections Code for the City is "a population that shares common social or economic interests that should be included within a single district for purposes of its effective and fair representation."

Possible features defining communities of interest might include, but are not limited to:

- School districts;
- Natural and artificial boundaries dividing line such as major roads, hills, or highways'
- Area around parks and other neighborhood landmarks;
- Common issues, neighborhood activities, or legislative/election concerns; and
- Shared demographic characteristics, such as:
 - > Similar levels of income, education, or linguistic insolation;
 - Languages spoken at home; and
 - Single-Family and Multi-Family Housing Unit areas.

Features that are not included in defining communities of interest are relationships with political parties, incumbents, or political candidates.

Maps Presented for Consideration – March 5 Public Hearing

As of February 26, 2022 at 9:30 a.m. a total of eight (8) maps have been submitted for consideration:

- Draft Maps #1-3 submitted by Redistricting Insights, the City's demographer
- Public Submission #1 by the Asian Pacific American Coalition (APAC) Board of Directors
- Public Submission #2 by the Asian Pacific American Coalition (APAC) Board of Directors
- Public Submission #3 by the South Bay Collective for Fair Representation
- Public Submission #4 by Herb Delute
- Public Submission #5 by Ted Godshalk

At the March 5 Public Hearing, Redistricting Insights will provide a presentation of all eight (8) maps to City Council for consideration, outlining how each may meet required criteria. City Council can then receive public comment and provide further direction to staff regarding the final maps. For discussion purposes, staff has requested Redistricting Insights number the districts 1-4 in a clockwise motion starting in the north.

Recommendation

It is recommended that the City Council review the maps submitted to date, and choose one or two preferred maps to focus analysis and consider one for final adoption at the March 15 public hearing.

It is recognized that each map holds its own challenges, and no single map is perfect, but each map presents a meritorious effort to meet both legal and practical demands of this specific districting process. By respecting the interests and concerns of the map proponents and acting without bias or favoritism in the best interest of the City and its residents, the City Council is asked to provide direction on map to consider at the final Public Hearing.

Next Steps

A decision on draft maps must be made at the March 5 Public Hearing to allow the public review period of seven (7) days prior to the final Public Hearing and adoption of map on Tuesday, March 15, 2022. The adoption of the final map of Council District Boundaries must be made at a Regular City Council Meeting.

Due to the consolidated timeline, at that March 15 meeting, the City Council will introduce and adopt an Ordinance amending the National City Municipal Code and establishing and implementing by-district elections for City Councilmembers.

The new district boundary maps must be submitted to the County Registrar no later than April 17, 2022 due to the timelines associated with the November election.

November 2022 Elections

If the City Council determines that the decision to hold by-district elections would be in the best interest of the City, the changes would be effective once an Ordinance is adopted and the Municipal Code changed to reflect the new process. Pursuant to California Government Code Section 34886, Councilmembers would be elected to represent a district, must reside in that district and be a registered voter in that district, as well as any future candidates. The Mayor would remain at-large representing the City as a whole.

The first by-district election would occur in November 2022 with the current terms of Mayor Sotelo-Solis, Councilmember Morrison, and Councilmember Rios ending. They may be considered for re-election depending on the final map adopted, which office they choose to pursue and the location of their residence.

For those Councilmembers currently in office at the time of the Ordinance codification, they shall continue in office until the expiration of the full term to which they were elected and until a successor is qualified. At the end of the term, each Councilmember thereafter, shall be elected on a by-district basis.







Please consider these maps that are equitably drawn by the South Bay Collective for Fair Representation reflective of the interests by National City residents and community organizations.

The undersigned community members and/or community organizations stand united in supporting the South Bay Collective For Fair Representation map that advocates for a Filipino/AAPI empowerment district, which strengthens the community's resident, voter, and business power for the 20% AAPI population in National City.

This map keeps the AAPI community together, although separated by two districts albeit next to each other. The Filipino/AAPI empowerment district designated as District 1 has 37.58% AAPI population density and 34.67% AAPI (VAP, while District 4 west of the Filipino/AAPI empowerment district has 17.4% AAPI population density and 18.47% AAPI CVAP, respectively. We acknowledge the surrounding areas of Kimball Morgan Towers with over 30% AAPI population density will be in District 4, underlining the high concentration of Filipino seniors who deserve greater resources. These numbers are statistically significant to underscore the goal for AAPI voter empowerment, mobilization, and representation. There is expectation for further growth of the AAPI population within the next 10 years. This map also supports the maintenance and growth of the AAPI business corridor spanning across Plaza Blvd from the northwest end of the city to the northweat.

Furthermore, this map seeks to advocate for the west side of Old Town National City District (OTNC) as District 3, highlighting the environmental impact of industrial zoning on residents. It is equally important to recognize that the west side has historically shared similar values and interests. The inclusion of OTNC as its own district advances progress for ongoing resident empowement in the area.

Please support these maps that keep our communities together in an equitable manner that allows your historically underrepresented constituents to thrive in collective empowerment.


