4. Review the Application for Naming/Renaming of City Facility and discuss and recommend to City Council naming the Barn at Doubletree Ranch Park the "Sgt. Dennis Oliver Event Barn." Chief of Police Doug Reim presented an application for naming the barn facility at Doubletree Ranch Park "Sgt. Dennis Oliver Event Barn".

The application fulfilled the requirements for naming/renaming.

Chief Reim along with two residents presented the backstory of why the department chose the Doubletree barn facility; citing that the Police Department uses the facility for the department's annual awards banquet.

Mr. Irwin asked how the Barn was chosen to honor Sgt. Oliver, or was there other options discussed. Chief Reim noted that Dennis was as big as life and much loved in the community. Chief Reim felt highlighting Sgt. Oliver's servant leadership and fun nature in a place where the community comes together was a good choice.

5. Receive a presentation and discuss barrier fencing options for the splash pad at Doubletree Ranch Park.

Director Lozano discussed the need to fence the splash pad to prevent further damage of the splash pad surfacing from wheeled activity such as skate boards and BMX bikes.

Michael Black of la terra Studio presented the Board with options for fencing the splash pad. Mr. Black stated that parks are meant to be open and airy, the fencing needs to fade away into the landscaping as much as possible. Currently the fence is a 3.5 foot tall heavy fence. Mr. Black presented 3 options of fencing Wireworks, Montage Commercial and a Wood/Mesh option. The Wireworks option uses a thinner wire and is designed to "see thru" the fencing. Montage Commercial is a standard wrought iron type fence. Wood and Mesh are very similar to what is at the splash pad now.

BACKGROUND:

Fiscal Year 2021-22 Council approved funding for the splash pad surfacing at \$183,103.

The existing rubber surfacing at the Doubletree Ranch Park splash pad was installed in early 2017. The splash pad was opened to the public in the summer of 2017, and the rubber surfacing has come to the end of its useful life. Staff has thoroughly researched various surfacing options and visited numerous splash pads throughout the metroplex.

Staff researched the following products:

- 1. Water Flecks
- 2. Life Floor
- 3. EPDM
- 4. Cool Deck
- 5. PolySoft
- 6. DuraPlay

From the research, staff determined that DuraPlay surfacing was the best product because it provides the most longevity, impact attenuation, and the least maintenance. The Warranty is 3 years, with a life expectancy of the DuraPlay product between 10 - 14 years.

Project Cost: \$ 183,103.00 (Includes: demo, dispose, scarification and install approx. 10,055 SF)

As of August 9th, DuraPlay cannot guarantee that the Chlorine Resistant Binder will be available this fall or next calendar year. DuraPlay cannot guarantee that the project will be completed before the next season's opening. Understanding this, I have low confidence that if we wait for the availability of the binder, we may miss opening the splash pad for next season.

Staff has contacted several other vendors that provide similar poured-in-place surfacing, and we have received no comments on the product's availability.

IDENTIFIED NEED/S:

Identify surfacing options other than poured-in-place that are available now for installation.

- Cool Deck type of light concrete
- Life Floor foam-rubber cushioned tiles

OPTIONS & RESULTS:

Staff visited the following cities and met with staff Life Floor

- Flower Mound
- Denton
- Grapevine

Expensive \$385,000 (vendor quote) The adhesive did not hold up Gaps in the tiles It did not hold up well in extreme heat Slipper when wet **Warranty** – 2 years with further limitations of extreme traffic, UV and chemical exposure Life Expectancy – STBD – Grapevine has had issues after one year

Cool Deck – light concrete

- Hurst
- Dallas

Budget Friendly \$169,905 (vendor quote) Very durable Hard surface Will develop cracks and chips over time Repairable **Warranty** – 2 years Life Expectancy - can range from 2 to 10 years

Note

an additional \$10,000 is earmarked for the removal and placement of the existing stones in the splash pad area

PROGRESS TO DATE:

Staff visited several municipalities in the North Texas area to get an understanding of the different splash pad surfacing options and provided information on the results.

BUDGETARY IMPACT/ORDINANCE CHANGE: (if appropriate)

We have set aside funds of \$183,105 for the project

RECOMMENDATION:

Make a recommendation for the replacement of the splash pad surfacing replacement to the Council

Options

1. Stay the course with DuraPlay and hope the binder becomes available and installed before next season. I do not feel that we should take a chance and wait for the binder to become available.

Or

2. Recommend cool deck light concrete type of surfacing; this would be the staff's recommendation.

Or

3. Recommend Life Floor
