Ron Stewart of McAdams addressed questions from the Park Board members.

Topics of questions were Wichita Forest Trail Markings and Trail Head, Wichita Forest trails should be added to the Comp Plan.

Mr. Irwin asked if the 2011 Trails Master Plan would be updated or if this comp plan would be the updated version. Mr. Irwin stated the 2011 plan had more information included. Mr. Irwin expressed desire to improve Wichita Forest to a more planned natural park.

Mr. Irwin asked if Pickle ball Courts could be included under the I35 overpass. Director Lozano stated that the area under the I35 overpass could be refined during the construction phase of Copperas Branch Park.

The Board members raised concern about Peninsula Park not being included in the Corp lease and agreed to discuss at a later date.

Mr. Irwin identified property boundaries of Bruce Lockhart Lions Club Park.

Mr. Fenderson asked about including the Denton County Water Trail in the Comp Plan. Director Lozano stated the plan would need to be added.

Mr. Heathington ask for clarification regarding bike lanes and bike boulevards.

Ron Stewart recapped changes that were discussed. They are as follows:

- Wichita Forest signage to meet current standards
- Incorporate 2011 Trails Master Plan into the Comprehensive Plan
- Lions Club verify property lines.
- Research verify approved plan for Marauder Park.
- Clarify Peninsular Park as Corp Property
- Add Denton County Water Trail to the Comp Plan
- Add yellow dot at Sellmeyer and HV Road as a node.
- Discuss removing the suggested 25 mile per hour speed limit from the Parks Comp plans.
- Leave map as is for Peninsula Park

Mr. Fenderson moved to recommend to City Council approval of the Parks and Recreation sections of the Comprehensive Plan update which includes the Trails Master Plan and The Parks and Recreation open space master plan as presented with the inclusion of the 2011 trails plan and the noted changes.

Pursuing a Lease agreement for Peninsula Park and the shoreline areas between Lakeside Community Park and Pilot

Knoll Park with the Corp of Engineers.

BACKGROUND:

In the November 7, 2022, Special Called Parks and Recreation Advisory Board Meeting, staff was asked to provide information regarding Peninsula Park and the shoreline that is currently not under a lease with the Corps.

The City of Highland Village entered into a lease agreement with the U.S Army Corps of Engineering (Corps) for the areas known as

- Copperas Branch Park
- Wichita Forest
- Lakeside Community Park
- Pilot Knoll Park
- Portions of Doubletree Ranch Park for areas located north of the pond adjacent to the lake and around the pedestrian bridge

The lease execution date was October 1, 2001, for 20 years. The Lease ended on September 30, 2021.

PROGRESS TO DATE: (if appropriate)

The city has received a letter from the U.S Army Corps of Engineering (Corps) expressing its intent to renew the lease and is currently in the process of renewing a lease for 25 years, which will include the following park sites

- Copperas Branch Park
- Wichita Forest
- Lakeside Community Park
- Pilot Knoll Park
- Portions of Doubletree Ranch Park for areas located north of the pond adjacent to the lake and around the pedestrian bridge

Received information from the Corps concerning the areas owned by the Federal Government and Managed and Operated by the Corps.

- The previous lease did not have Peninsula Park or the shoreline areas between Lakeside Community Park and Pilot Knoll Park
- The new lease will not have Peninsula Park or the shoreline areas between Lakeside Community Park and Pilot Knoll Park
- The Corps will consider a stand-alone lease for the additional Corps federally owned sites, including Peninsula Park and the shoreline areas between Lakeside Community Park and Pilot Knoll Park, if the city is willing to address the illegal
 - > tree trimming
 - > mowing
 - boat docks
 - unauthorized storing of vessels
- We received a quote from McAdams to provide an Impact and Feasibility Study for the additional remaining Corps land currently not in our lease and within the city limits

BUDGETARY IMPACT/ORDINANCE CHANGE: (if appropriate)

\$47,500 for an Assessment and Impact Study before moving forward with leasing the new areas.

RECOMMENDATION:

Provide a recommendation to the council to

- 1. Request funding to be performed immediately for an assessment and impact study of the Shoreline Corps land currently not under lease by the city.
- Request funds during the budget process for an assessment and impact study of the Shoreline Corps land currently not under lease by the city in the 2023-2024 budget.
- 3. Do nothing and leave as is
