#### Background

As part of the annual budget process, the City considers potential capital improvement projects. These projects are listed as proposed public works in the annual Capital Improvement Program (CIP). Government Code Section 65401 requires that the Planning Commission review the list of proposed public works and report to the City Council on the conformity of the CIP with the General Plan. The proposed projects for Fiscal Year 2023-24 are attached along with a conformity review, which identifies the General Plan policies that support each project.

#### Recommendation

Determine that the proposed CIP projects for Fiscal Year 2023-2024 are in conformity with the adopted General Plan.

#### **Proposed Projects/General Plan Conformity Review**

#### 8th St Bicycle and Pedestrian Rail Crossing Enhancements

<u>Project Description</u>: Construct a two-way Class 1 safe crossing of the rail tracks near 8th and Harbor in National City for bicyclists and pedestrians. Removal of a vehicle free right-turn lane.

<u>Project Location</u>: Between the Bayshore Bikeway at the intersection of 8th St and Harbor Dr., crossing the rail tracks to the east of the intersection, ending west of the 8th St MTS transit station

Implementing General Plan Policies

- Policy C-2.2: Enhance connectivity by eliminating gaps and barriers in roadways, bikeway, and pedestrian networks.
- Policy C-4.5: Encourage the use of alternative transportation modes.
- Policy C-9.1: Expand and improve the bikeway system and facilities by establishing bike lanes, separated paths, and bicycle storage facilities at major destinations.

#### 22<sup>nd</sup> Street Separated Bikeway

<u>Project Description:</u> 3,000 feet of separated bikeway (Class I and IV), curb extensions, a new traffic signal with bike signals, continental crosswalks, curb ramps, and 400 feet of new sidewalk.

<u>Project Location</u>: This project is located along East 22nd Street between Wilson Avenue and D Avenue in National City, CA.

#### **Implementing General Plan Policies:**

- Policy C-2.2: Enhance connectivity by eliminating gaps and barriers in roadways, bikeway, and pedestrian networks.
- Policy C-4.5: Encourage the use of alternative transportation modes.
- Policy C-8.5: Improve pedestrian safety at intersections and mid-block crossings.
- Policy C-9.1: Expand and improve the bikeway system and facilities by establishing bike lanes, separated paths, and bicycle storage facilities at major destinations.

#### 24<sup>th</sup> Street Transit Center Connections

<u>Project Description:</u> Construct more than two miles of separated bike lanes (Class IV), 2 curb extensions, traffic signal modifications with bike signals, continental crosswalks, and curb ramps.

<u>Project Location</u>: This project is located along E 30th Street between Hoover Avenue and Highland Avenue, and along Hoover Avenue between E 33rd Street and E 22nd Street.
