- **ORDINANCE 2, 2019** (1ST READING) SMALL SCALE COMPREHENSIVE a. PLAN AMENDMENT. AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, ADOPTING A SMALL-SCALE AMENDMENT TO ITS COMPREHENSIVE PLAN FUTURE LAND USE MAP IN ACCORDANCE WITH THE MANDATES SET FORTH IN CHAPTER 163, FLORIDA STATUTES, SPECIFICALLY SECTION 163.3184, ET SEQ., FLORIDA STATUTES. PURSUANT TO APPLICATION NO. CPSS-18-08-000011 THAT PROVIDES FOR AN AMENDMENT TO THE CITY'S FUTURE LAND USE MAP BY DESIGNATING TWO (2) PARCELS OF REAL PROPERTY COMPRISING APPROXIMATELY 0.68 + ACRES IN SIZE, MORE OR LESS, AS "(C) COMMERCIAL": SUCH PARCELS BEING LOCATED AT THE SOUTHEAST CORNER OF THE INTERSECTION OF ALTERNATE A1A AND FLORIDA BOULEVARD APPROXIMATELY 0.5 MILES SOUTH OF THE INTERSECTION OF ALTERNATE A1A AND HOOD ROAD; PROVIDING FOR COMPLIANCE WITH ALL REQUIREMENTS OF CHAPTER 163, FLORIDA STATUTES; PROVIDING FOR TRANSMITTAL TO THE FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY (DEO); PROVIDING THAT THE FUTURE LAND USE MAP OF THE CITY OF PALM BEACH GARDENS BE AMENDED ACCORDINGLY; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE. AND AUTHORITY TO CODIFY: PROVIDING AN EFFECTIVE DATE: AND FOR OTHER PURPOSES.

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, REZONING CERTAIN REAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF PALM BEACH GARDENS.
