SUBJECT: Americans for the Arts – Arts & Economic Prosperity Study

RECOMMENDATION: Staff recommends Public Art Committee members receive and file report.

BOARD/COMMISSION PRIOR ACTION: None

STATEMENT ON SUBJECT: On August 17, 2021, the San Diego County Board of Supervisors voted unanimously to approve the reestablishment of an Arts and Culture Commission. This would help to bring new sources of funding for arts in the County. From an economic standpoint, the U.S. Bureau of Economic Analysis reports that the arts and culture sector contribute \$185.5 billion to California's economy, representing 7% of our state's GDP. City staff were recently alerted to the Arts & Economic Prosperity Study that is available through Americans for the Arts.

City staff were alerted in 2021 to the Arts & Economic Prosperity Study that was available through Americans for the Arts. This study's purpose was to measure the economic impact of spending by the nation's nonprofit arts and cultural organizations and the event-related spending by their audiences during fiscal year 2023. This quantifiable impact can help to identify arts and culture as a driver of community and economic development. The cost for the study was \$2,475 and was approved by this body and the City Manager to facilitate our participation. Participation in the study entailed data collection through surveys of attendees and participants of arts-related programming. ARTS and City staff worked together to capture the survey information and submit the data to Americans for the Arts. The study results are due to be released in late October 2023.

SUBJECT: John Baldessari Commemoration Project

RECOMMENDATION: Staff recommends Public Art Committee members receive and file the update regarding the John Baldessari Plaque project.

BOARD/COMMISSION PRIOR ACTION: At the January 26, 2021 meeting, PAC members voted on the language for the plaque. At the July 27, 2021 meeting, the Public Art Committee voted to fundraise for the plaque and to work with ARTS as the fiscal agent for this project.

STATEMENT ON SUBJECT: The Public Art Committee has been working towards the goal of placing a plaque by the local house immortalized in John Baldessari's famous work, "Wrong." Baldessari, born and raised in National City, was a leading figure in the conceptual art movement in Postwar America. The design for the plaque had been approved at a prior meeting. Fundraising and the fiscal agent, ARTS, had also been approved. The Committee raised \$2,000 for the creation and installation of the plaque, with an additional \$500 pledged.

At the April 25, 2023 meeting, discussion included the plaque design as a bronze marker in the sidewalk. In addition, there was discussion regarding more meaningful ways to commemorate the work of John Baldessari in the community with a more people-focused approach. City staff and ARTS staff are hoping to have cost estimates for the bronze medallion and installation at the July meeting.
