An ordinance amending Section 2-24 of the Victoria City Code to clarify that City Council has adopted Robert's Rules of Order as its parliamentary procedure, repealing all conflicting ordinances, providing for codification and savings, and declaring an effective date. *First Reading. - 2. An ordinance adopting a moratorium and prohibition on accepting, processing, or acting upon applications for any Game Room Permits as described in Section 14-146 of the Victoria City Code, extending the expiration date of all current active permits, suspending the operation of conflicting ordinances, declaring an emergency, providing for publication, enforcement, and savings, and declaring an effective date. *Emergency Reading.
