Fixed-income securities offer a predictable stream of interest payments and return of the loan over a specified period.

Fixed-income investments are important for investors for portfolio diversification and providing stability, helping offset the volatility of more high-risk assets. Fixed income securities attract conservative investors for their predictability and low volatility.

When you buy a bond, you lend money to Amara Rae. You receive interest for this loan from us on regular basis and Amara Rae repays the loan over a certain period. The expectation is that the Wellness and Longevity bond at Amara Rae is paid back within 3 to 5 years with interest.

We will keep you posted about the progress of our setup, growth and repayments. In this way a transfer takes place every period. This way, your investment comes back to you with an attractive return.

## Questions, answers and explanation

Rules that apply to our sale of bonds: You can register online via amararae-community.com. You pay the amount that you lend to us. We deliver the bonds within three days after the statutory cooling-off period.

## What are bonds?

An alternative for more interest on your assets. By purchasing corporate bond(s), you provide a loan to the issuing institution. In return for this, you receive a fixed interest on the investment. The issuing institution also repays the loan per period. We call this loan a bond.

#### Consideration

It is wise to first familiarize yourself with our company. Although investing is not without risk, it usually yields more financial benefit than saving. However, it is very important that you have the right knowledge. The fact that you are reading our information memorandum is therefore a good sign.

# Limit your risk

Does a high interest always entail more risk? Yes, but you can limit the risk yourself by spreading your investments. Never invest money that you cannot afford to lose. It is not wise to use your entire savings account, because investing always entails risks.

# Start investing immediately?

That is possible. You may already know from experience what the risks can be. Corporate bonds are a separate asset class. The risk, or the return ratio, is not comparable to other investment products such as ship CVs, government bonds or real estate and investment funds. Also read the remaining documentation.

# How can I buy bonds?

Safely via your bank. You can pay for Corporate Bonds via iDEAL or via a bank transfer. You will receive your payment confirmation by e-mail. You will also receive login details with access to your own personal investment dashboard.

# 14 days' reflection period

After your payment, you have a statutory 14-day cooling-off period to cancel free of charge. You do not pay any management or closing costs (no hidden costs).

# Can I cancel the purchase of bonds?

Yes, the AFM believes it is important that you as a consumer make a conscious choice to invest. That's why we offer the possibility of reflection. This is designed in two ways: You must be active confirm that you have read the information memorandum before you press the order button. You have the option to cancel for 14 days. This can be done by written confirmation. There are no costs associated with this cancellation. If the investment is not canceled within 14 days, it will then become final.

#### How can I sell or transfer bonds?

Bondholders who wish to transfer their bonds must indicate this in writing to the issuing institution. This can be done by e-mail.

### What is Crowdfunding?

Crowdfunding is the lending of relatively small amounts by a large group of investors to a company via an online platform. When lending money to a company, the compensation is interest on the loan. This form is called 'loan based crowdfunding' or 'crowd lending'. With this form of crowdfunding, financial return is important.

### Does this bond loan fall under Crowdfunding?

No, with crowdfunding you take out a loan via an intermediation platform between lenders and borrowers. A crowdfunding platform must perform a crowdfunding investor test on every consumer who invests more than €500 via the platform. With us, you invest directly in the company itself. You provide the company with a loan and decide for yourself how big the loan is.

## Where can I find the essential investor information?

Essential investor information is information that you need in any case to be able to make a well-considered decision. Under the heading Documentation on the website you will find the legal information document submitted to the AFM. You will also find information about, among

other things, the risks, the securities and guarantees, the terms of the loan, the tax treatment and the current financial situation of the issuing institution.

# What does "no prospectus obligation" mean?

An investment offer usually requires a license or the company must have a prospectus approved by the AFM. Sometimes exemptions apply and an investment offer does not fall under the supervision of the AFM. We then speak of an exempt investment. For example, an investment is exempt if

all investors can jointly invest a maximum of €5 million in the investment. Source: AFM.

## How can I invest?

# Step 1: Register

You can first register before you can start investing. This can be done as a natural person or on behalf of a company.

# Step 2: Payment

You can complete the registration via iDEAL or via a bank transfer.

## **Fully subscribed**

When the amount of the bond loan has been reached, it will be given the status "Fully subscribed". It is then no longer possible to invest. Each investment has a statutory cooling-off period of 14 days, during which an investor has the right to change or cancel the subscription. The bond loan will retain the status "Fully subscribed" until the cooling-off period for all subscriptions has expired.

## **Essential investment information**

Essential investor information is information that you need in any case to be able to make a well-considered decision. This investment includes a legal information document (AFM document)

and information about, among other things, the risks, the securities and guarantees, the conditions of the bond, the tax treatment and the current financial situation of the issuing institution. You can find this in

the other financial documents to be downloaded from the website of the issuing institution. Exemption from the Prospectus obligation means that an exemption applies and that this investment offer is not subject to supervision by the AFM. We then speak of an exempt investment. An investment is

exempt, for example, if all investors can jointly invest a maximum of €5 million in the investment within a period of 12 months.

# Why can a prospectus be exempt from approval by the AFM?

If one or more of these points occur, a prospectus is exempt from approval by the AFM: The offer is aimed at fewer than 150 people; The securities can only be acquired (whether or not in a package) for a value of at least €100,000 per investor. The offer of securities by a non-profit association or institution to realise its non-commercial objectives. The nominal value of a security is €100,000 or more:

Or, as with the offer of the issuing institution: The total consideration of the securities that are

offered is less than €5 million, calculated over a period of 12 months. It is also possible that an approved

prospectus is not available for an offer because the offer is not prospectus-obligatory. This is the case, for example, if the securities are not tradable or if it concerns an offer of participation rights in an open-end investment institution. Source: AFM
