The Stewards, having received Report from Clerk of the Course and photos, summoned and heard the crew of the above competitor. Having considered the following matter, the Stewards determine as follows:

**Facts:** The Report from Clerk of the Course and photos available to the Stewards shows that on the SS 2 the crew No. 6 (Stříteský Dominik / Hovorka Jiří) used wheel which they got from another competitor.

**Offence:** Breach of FIA International Sporting Code (ISC) Art. 12.2.1.1 and Art. 56.1.2 FIA Regional Rally Sporting Regulations 2022

**Decision:** Disqualification of Crew St. No. 6 (Stříteský Dominik / Hovorka Jiří)

**Reason:** The Driver, Dominik Stříteský, accompanied by his co-driver and representative of the Competitor, appeared in front of the Stewards today at 21.05 hrs. The driver stated that on SS 1 he had a double puncture. Because he had only one spare wheel in the car, he asked the crew st. no. 14 if he can borrow their spare wheel. With this wheel, they completed SS 2. After the finish of SS 2, they returned the wheel to the crew st. no. 14, as they found out that they can maintain the pressure in one of their punctured tires, with the equipment they had in car. The crew thought they were not breaching the regulations by having a spare wheel from another competitor. The stewards explained the crew that they had breach the regulations of the ISC and RRSR as they attempt to influence the result of a Competition in a way that is contrary to sporting ethics as they received the external assistance.

The Competitor is reminded of his right to appeal which is stipulated in the 2022 FIA International Sporting Code and in the 2022 FIA Judicial and Disciplinary Rules.  
The competitor stated that he would not appeal.
