The Stewards, having received report from the Clerk of the Course (Doc. 7.3), summoned and heard twice the above crew member (summon No 4.3), first heard on 11.06.2022 at 21:50 and second heard on 12.06.2022 at 11:00, have considered the following matter, determine the following:

Driver and car No: Radosław TYPA, #13

Competitor: GO2NFT

Fact: A vehicle belonging to the driver had fake access code sticker on it.

Offence: Breach of Article 12.2.1.c of 2022 FIA ISC

Decision: **No further action during ORLEN 78th Rally Poland**

To forward the case to the ASN of Poland (PZM) for possible further action after police investigation.

Reason: On June 11th The Rally Route Chief forwarded a report to the Coc (doc 7.3) concerning a vehicle found in the service park on June 10th with a fake All Access sticker. The Polish police was called and they started a legal investigation (doc 7.6).

Beside the legal aspects of this case it is also a sporting severe infringement according to art 12.2.1.c of ISC. Consequently, the Stewards summoned and heard the driver, representing also the competitor and the co-driver. The hearing was made in two parts, the first one on June 11th and the second one on June 12th to allow the competitor to bring elements for his defence.

The concerned vehicle with the fake sticker stucked on the windshield belongs to the driver of car No 13. This driver owns 197 vehicles to be rent by other parties.

According to the statement made by the driver expressed in the letter (doc 7.7) and by the invoice (doc 7.8) forwarded to Stewards, the incriminated vehicle was rent by a company not having any relationship neither with the competitor No 13 nor with the organizer.

Having analysed all available evidences, the Stewards cannot establish and prove any connection of the incriminated car with the competitor No 13 in the framework of the rally.

Therefore, the ASN of Poland (PZM) being a party of this matter will be able to get full information after further police investigations and will have consequently all elements to finalize the sporting aspects related to this matter.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

According to Art. 12.3.3.b of the Code this decision of the Stewards becomes immediately binding even in the event of an appeal, since it concerns a matter of safety.
