\*\*\* Destination charges of shipping line for processing delivery order. Free period for use of container in Kenya must be handled from origin to obviate demurrage charges payable to the shipping line, ideally apply for 30 days as free period.

\*\*\*\* Processing of Carnet of the motor vehicle, packing list & commercial invoice of spares be sent earlier for purposes of Kenya Bureau of Standards Local Certificate of conformity and also the execution of the Bond.

\*\*\*\*\* This is an optional extra if competitors don't want to go and empty the container from the depot in Suswa.

\*\*\*\*\* This is an optional extra, if competitors want the same container for the return journey, MICD will store the container at their respective depot.

\*\*\*\*\* This is an optional extra if competitors want the same container transported to Vipingo Ridge.
