5. Report of the Clerk of the Course:

Track inspection was carried out at 7:50 all services were according Homologation Report
All Warm-ups, exclude AA 125, SSP300 was interrupted due to fall and Races 2 were held according
Timetable v.3 and Supplementary Regulation.

Today, we received appeal from rider 194 Szysom Jusztynu SSP 300 related to yesterday decision for
disqualification in Race 1 due to not gave his bike to Parc Ferme. Protest was sent late, without any
signature and Fee. Appeal was declined and explained to rider.

Penalization for Wiktor Ostrowski, Heros Mennito STK 1000 received 5 sec penalty for jump starts, no
remarks.

6. Technical report:

Walter Glueck reports that the following number of motorcycles passed the technical scrutineering:

In the starting grid of class SSP 300 rider # 232 (Mihai Alexandru Voinea) had no shark fin protector on the
swingarm of his motorcycle.

In the starting grid of class 600 rider # 69 (Karol Weiss) had no helmet sticker, rider # 10 (Dusan Kovarik)
had no safety light on his motorcycle. Rider # 23 (Wojciech Wieczorkiewicz) had no tire stickers.

In the starting grid of class STK 1000 rider # 17 (Wiktor Ostrowski) stated the he is not riding in Alpe Adria,
only in Polish Championship, he had no tire stickers. Rider # 48 (Jan Kysucan) had no tire stickers.

In the starting grid of class SBK rider # 76 (Richard Balcar) had no helmet sticker.

After the 2nd races we checked the minimum weights of the first three motorcycles in Alpe Adria classes
SSP 300, STK 600, STK 1000 and SBK. Result: All ok.

Remark to have selected classes for FIME, AA riders in paper form to have a list of passed admin riders
and use it for control of tyre stickers on grid.
