In addition to the Covid-19 Speed Skating Competitions protocol approved with FISG President's Resolution no. 300 of 13 September 2020, the following specific directives for the discipline apply during the Long Track races

#### **Covid Manager**

FISG will make available the person of Mr. Luca De Carli, a dedicated figure called "FISG Covid Manager" who will support the OC's Covid Manager preparing all the actions described above.

Alongside the OC's Covid Manager and the FISG Covid Manager, the presence of at least three persons, members of the Organizing Committee, will be required to carry out administrative and control tasks during the competition, with the assignment to report potentially dangerous and non-compliance situations with health obligations by the participants

#### **General Measures**

- The installation of Termoscanner (fixed or mobile) will be provided for all entrances reserved for Athletes, technicians, managers, Jury and Organization staff;
- Dispenser to sanitize hands must be positioned at the entrance and inside the structure and facilitate their use through special signs;
- Indications from the arrival Triage to the assigned sector of each person must be installed (dressing room, technical area, jury / timing cabin)

#### **Spectators**

The presence of spectators inside the IceRink is not allowed

#### **Entry Procedure**

Before arriving to the entrances of the IceRinkt, an area called Triage is created by OC in collaboration to Covid Managers, accredits the participants to the event, verifies the presence of the Covid Documents (self-certification) and then the temperature control via Termoscanner.

Access is allowed only after delivery of a specific identification (pass or bracelet), which must be visible and must be shown whenever requested by the OC's security officers.

#### IceRink's Zoning

- The IceRink, as per specific annexes for Baselga di Pinè and Collalbo, is divided into three areas:
- ice / warm-up area / coaching area (access allowed only to members of the Sports Area and the First Aid staff)
- work area (access allowed only to operating personnel staff / referees / security / timekeepers)
- public sector (spectators, press officers, journalists, sponsors, family members)

#### Teams' arrival to the IceRink

- all participants must follow the accreditation procedure (see paragraph "Entry Procedure")
- the use of the mask is mandatory until access to the ice and in any situation does not allow compliance with the spacing obligations provided for by current legislation
- the athletes will enter the competition area according to the order of the groups established in the competition program, following the rule of the "Temporary Bull", according to which from the moment of access to the end of their competition of the day they will not be able to leave Competition area, except in cases of urgency or emergency authorized by the Covid Manager

#### Warm Up

- Athletes must have a special and identified outdoor area available for heating off the ice (stretching, warm-up ...)
- the warm-up on ice takes place in groups as per the competition protocol
- the OC must make rubbish bins available for the disposal of papertowels and bottles of water. FISG will provide all italian athletes, on the occasion of the first competition in which they will participate, a large bag where to deposit their protective gear and clothing during the warm-up on ice and the dispute of their own competition heats.

#### **In-field Entry**

- It takes place individually before the start of the race, therefore there is no crowding.
- The Starting Area, that welcomes the athletes of the Long Track before entering the track at the time of their heat / competition, must be set up to allow the correct distance between the athletes in full compliance with current legislation. Athletes will deposit their clothing, skate's cover and mask in the personal bag provided which will be kept separate on special tables placed in the in-field, in compliance with competition safety regulations. On the tables will be available the disinfectant to sanitize their hands.
- Athletes will wear personal bands according to the starting position (white red blue yellow).

#### **After the First Distance**

- Athletes leave quickly the ice without giving handshakes or hugs to their staff and retrieving the bag with their personal effects, then reaching the changing rooms and the area reserved for cool-down and / or warm-up between the first and second distance of the day
- Coach and / or Athletes stay with Media (television interviews, journalists) in a reserved area, guaranteeing the required distance

#### Exit from the IceRink

- Athletes, once their competition is over, leave the stadium giving their place to the athletes of the following competition groups
- There is no contact with spectators

#### **Dressing Rooms**

Training guidelines must be observed, guaranteeing a minimum distance of 1 meter between one person and another:

- athletes, coaches, technical staff must minimize contact with other people present in the Rink;
- each athlete must use their own water bottle and their own towel;
- the use of showers is prohibited for safety reasons.

#### Coach Area

The area where coaches can follow their athletes during the competition ("coach area") must be well identified and there must be no possibility of contact with spectators, journalists or other people in the stands. When there are more technicians on the track, the distance must always be guaranteed

#### Referees

Each competition will see the presence of a number of refrees and officials as indicated in the regulations. The following criteria must be met for match officials:

- an area is identified (jury and timing cabin) for the exclusive use of officials and race technicians, with the indication of the maximum capacity, subject to control by the Covid Manager or persons appointed by them
- before the start of each competition, the positions of referees and officials must be sanitized by the OC. Technical equipment is made available already sanitized by the FISG tender services representatives;
- about starter footboards, after each change of starter the stations must be sanitized.
   Technical equipment (headphones and microphone) must be restored (replacement of microphone cover and headphone cover) and sanitized, unless they are for the personal use of each starter only.
- referees and official's access to his own station and to the race preparation activities takes place only after accreditation to the Triage and consequent authorization of the Covid Manager.
- use of the mask during the competition including the judges on the ice too;
- referees and officials never have contact with spectators or Media

#### **Additional Measures**

The following preventive measures must be implemented:

- athletes, technicians and officials must not shake hands before and after the competition
- the awards must be organized in such a way that the awarding subjects and the awarded subjects must wear the mask and the awarding must be carried out in such a way that there is no physical contact between the subjects; all the people touching the prize have to be previously disinfected their hands
- the competition documents (starting orders, results, communications from the jury) will be available in an exclusively electronic format, through the Sportity-Fisg app, made available to all participants with free access and passwords; paper copies of the starting orders will be distributed only to the officials
- to avoid the risk of crowding, notice boards showing the tender documents will NOT be used and installed
- any form of catering and administration of food and drinks is prohibited within the competition area
- the payment of the registration fees will be made exclusively by bank transfer, abolishing cash transactions that represent potential vectors of the infection

### All. 2 --- Informations on App Sportity

#### "SPORTITY" mobile application for tablets and smartphones

Daily information, programs, starting lists and results will be communicated on the "Sportity" mobile application for tablets and smartphones. This mobile application makes the information delivery faster, contains all relevant information for participants, reduce paper needs and notify participants in case of any changes or urgencies through push notification possibilities.

The "Sportity" app is available free of charge on Android and Apple systems and is compatible with both tablets and smartphones. It can be downloaded with the below QR codes or directly on the app stores.
