The Stewards having received a report from the FIA Technical Delegate have considered following:

**Facts:** At pre-event Scrutineering it was found that car no 212 does not comply with App. J 283-8.3 and Art 2.1.1.c.3i of the homologation regulation for safety cages, the Competitor requested additional time to fix the issue. After the Start List for TC 0 was published, FIA Technical Delegate made a verbal report to the Stewards that Competitor no 212 will not participate in the Event.

The Stewards issued Summon no 1 to receive an explanation from the Crew no 212.

The Driver of the Crew no 212 at the hearing held in Stewards meeting room 4<sup>th</sup> Feb 2021 at 19:45 explained that they were intending to fix the issue to be comply with the App. J 283-8.3 and Art 2.1.1.c.3i but after further investigation realised the rebuild would not be possible.

As soon as it was recognized the Crew informed Technical Delegate that they have no ability to fix an issue and to participate in the Event.

**Offence:**

- breach App. J 283-8.3 and Art 2.1.1.c.3i of the homologation regulation for safety cages
- breach of ISC 2021 Article(s) art. 12.2.1 b and art 12.2.1 c

**Decision:**

**Disqualification of the Competitor no 212**

**Reason:**

According to the information received from Competitor no 212 during the meeting held 4th Feb 2021 concerning the Report of Technical Delegate no 6.1 the Crew no 212 have no ability to rebuilt the Car to follow App. J 283-8.3 and Art 2.1.1.c.3i of the homologation regulation for safety cages Taking into account that the Car #212 is not comply App. J 283-8.3 and Art 2.1.1.c.3i of the homologation regulation for safety cages, the Stewards cannot allow the Car to take part in the Event.

Concerning the alleged breach of ISC 2021 Article(s) art. 12.2.1 b and art 12.2.1 c mentioned in the Summon no 1 the Stewards decided no further action.

The Competitor is reminded of his right to appeal according Art. 15 of the FIA International Sporting Code.
