7.2. Scrutineering, mandatory documents

Team representative must be prepared for presentation of below documents:

- Cars' complete original FIA homologation form (T2);
- Cars' complete original FIA Technical Passport (T1, T2, T3 and T4);
- Cars' complete original certificate of fuel tank and safety cage;
- SOS / OK board (DIN A3 format);
- Scrutineering Card (BK 1 card) (received during the Collection of Documents and Materials);
- filled in FIA Safety Form (received during the Administrative Checks).

The complete original FIA homologation form / FIA Technical Passport and all other necessary certifications/documents must be available for final checks.

The installation of the tracking system and the NAV-GPS will be checked at scrutineering.

7.3. Timetable for scrutineering

Any delay at Time Control before entering the Scrutineering in relation to scheduled time will result in administrative penalties:

- The first 15' of delay: 50 EUR.
- From 16' up to 1 hour of delay: 100 EUR
- Every following hour or fraction of delay: 100 EUR each hour.

7.4. Mud flaps

According Art. 25.3.4 of the FIA CCRSR mud flaps must always be in place and efficient.

7.5. Drivers' safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III.

The cars must be equipped with the medical kit according FIA CCRSR Appendix III-1 and FIA Technical List n°83 and the survival kit according to FIA CCRSR Appendix III-2.1.

8. SHAKEDOWN

8.1 LOCATION AND DATE

The Shakedown will take place on 27.08.2021 / Friday / hours 10.00-15:00 in Wolczkowo village.

8.2. RUNNING

The Shakedown will be run at the same conditions as a Special Stage, including timekeeping and especially Crew members and vehicle safety equipment.

The vehicle must be the one indicated in the entry form to 2021 WYSOKA GRZĘDA BAJA POLAND. The Crew and the vehicle will be only allowed to participate in Shakedown when the required entry fee will be paid in fully.

All vehicles will start with an interval no less than one (1) minute. The starting order will be based on the arrival time at the preset zone and the Crews can make as many laps as they wish.

8.3. SHAKEDOWN SERVICE ZONE

Next to the Shakedown zone, the Organizer will provide an area where it will be possible to service on the entered competing vehicles.

9. BRIEFING

Necessary information's will be provided during collection of materials and documents.

Drivers' Briefing will be performed on-line via DNB.

10.1 Availability of participants

Competitors and Crew members who parked their vehicles in the Parc Fermé upon passing the finish line, must remain available by phone (mobile) until the Final Classification have been posted.

All Competitors, Crew members and their accompanying persons are obliged to obey the:

- National Traffic Laws of Poland;
- applicable sanitary guidelines are available on official rally website www.bajapoland.eu ;
- and other applicable regulations.

All Competitors, Crew members and their accompanying persons are obliged to obey all mentioned above regulations.

11. CEREMONIAL START / OFFICIAL RALLY START

11.1. Official Rally Start, procedures and order

Rally Start is also the start of Leg 1.

Starting order to Rally Start will take place according to Starting List to Leg 1.

The Rally Start will be run as a passage of each Crew through the presentation ramp, which will be set near TC 0. All Crews are obliged to move according to Road Book and instruction given by marshals and Organizer personnel.

11.2. Pre-start Park

Each entered competing vehicle must be put to Parc Fermé "A" before the Rally Start on 27.08.2021 / Friday / up to 15:30.

Members of Competitors/Crews team personnel are allowed to put entered competing vehicle into the Pre-Start Park.

12. QUALIFYING STAGE

12.1. LOCATION AND DATE

The Qualifying Stage (QS) will take place on 27.08.2021 / Friday / in Military Training Ground, Szafera street, Szczecin.

12.2. RUNNING

The Qualifying Stage will be run as a Special Stage in Section 1 Leg 1 and will determine the starting order for Section 2 Leg 1, and all Crews must take part in it.

12.3. SCHEDULE / STARTING ORDER

Starting order and intervals will be the same as for Rally Start (TC0). 1st crew will start after the last Rider from accompanying motorcycle competition (MPRB, PPRB). The first Crew from national competitions (FIA-CEZ, RMPST, DDMC, MMCR, RPPST and Baja Poland Series) will start after the last Crew from the FIA World & European Cup for Cross Country Bajas competition.

12.4. RECONNAISSANCE OF THE SUPER SPECIAL STAGE

Any reconnaissance with the QS route is prohibited

12.5. CHOOSING STARTING POSITION FOR SECTION 2 LEG 1

In accordance to the Art. 33.5 of the FIA CCRSR, after the Stewards have declared the QS classification final the first ten Competitors from the Qualifying Stage classification must go to the designated location on Rally HQ with the Competitors Relations Officer (CRO) (**Kinga Kaźmirek +48 788 421 235 & Marek Kisiel +48 723 302 302 E-mail: marek.kisiel@pzm.pl**) for choosing their starting position for Section 2 Leg 1.

The first nominated Driver will be responsible for choosing the position and must be present throughout the above-mentioned procedure.

13. NECESSARY TECHNICAL INSTALLATIONS

13.1. Tracking System

All vehicles must only be fitted with the GEOTRAQ Safety Tracking System provided by the Organiser.

Safety Tracking System elements will be delivered to crews during Collection of Materials and Documents and must be mounted by crew before Scrutineering.

The rent fee for the GEOTRAQ Safety System unit is included in the entry fee.

Each Crew must also pay to the organizer 250 EUR of refundable deposit for each complete GEOTRAQ safety system set, which will be returned upon return of undamaged and complete set.

The system manual is presented in Appendix 5 to SR.

13.2. Navigation System (NAV-GPS)

GEOTRAQ Safety system will be used as official NAV-GPS to control the Speed Control Zones, Passage Controls and Waypoints (without navigations function).

13.3. Connection of the Systems

It is the competitor's responsibility to ensure that the GEOTRAQ Safety Tracking System always remain permanently connected and switched on with the antenna connected throughout the duration of the competition.

13.4. FIA Data Logger

Vehicles selected by the FIA after the publication of the entry list may be equipped with an FIA Data Logger to monitor their performances during the event.

13.5. FIA Accident Data Recorder (ADR)

Vehicles selected by the FIA after the publication of the entry list may be equipped with an FIA Accident Data Recorder (ADR) to record the forces sustained by the vehicles and their crews during any event

13.6. FIA On-Board Surveillance Camera (FIA OBSC)

Vehicles selected by the FIA may be equipped with an FIA OBSC to monitor all activities inside the vehicle during the event.

13.7. On-Board Cameras

See FIA CCRSR Art.11. Competitors wishing to use a camera must supply the following information to the Organiser at least one week before the start of the rally: Competitor's name, car number, competitor's address and use of footage. All informations must be sent by the organizer's e-mail address: biuro@bajapoland.eu till: 20.08.2021, 23:59.

14. STARTING SYSTEM FOR THE SPECIAL STAGE

At each Start, there will be 2-digit electronic starting device with 2 green lights, coupled with a photocell responsible for detection of false starts.

The photocell will be placed about 50 cm beyond the start line. The display will be placed so to be well visible to a Crew sitting in a vehicle on the starting line.

The vehicle with the Crew is placed at the start line. The starting device continuously counts down to the moment of the green light. Numbers are shown in the sequence: 30, 15, 10, 5, 4, 3, 2, 1 and the green light. The green light will stay on for 20 seconds.

Within this time, a Crew must start.

15. SERVICE PARKS, PARC FERME, REFUELLING

15.1. LOCATION

During the Rally, the Service Park will be located in:

- Szczecin-Dąbie Airfield, Przestrzenna street, 70-800 Szczecin (Flexi Service A, Service D).

During the Rally there will be one Remote Service Zone, which will be located in:

- "Remote Service Zone – Drawsko Pomorskie", Toruńska street, Drawsko Pomorskie / Parking / (Service B, Service C).

- "Remote Service Zone – Shakedown", Wołczkowo (Shakedown Service)

15.2. FLEXI SERVICE

For the operation of 30 min. flexi-servicing, crews will enter the Parc Fermé. After a publication of Final Classification of QS crews may then either enter the Service Park or leave their car in the Parc Fermé B. According to FIA CCRSR Art. 53, the competing car may be driven by an authorised representative of the competitor only from the Parc Fermé B to the Service Park (TC 1B) and vice versa (TC 1C) respecting all the formalities of time card presentation and related penalties. The competing car may be conducted to the overnight Parc Fermé B before the 30 minutes have elapsed without penalty. All cars except re-starting crews have to be in the overnight Parc Fermé no later than at 23:30.

15.3. PARC FERMÉ (PF)

15.3.1. Location and number

The following PF's will be arranged on Szczecin-Dąbie Airfield:

Parc Fermé "A" on 27.08.2021 – PF before the Rally Start

Parc Fermé "B" on 27-28.08.2021 - overnight PF before Leg 1 Section 2

Parc Fermé "C" on 28-29.08.2021 - overnight PF before Leg 2

Parc Fermé "D" on 29.08.2021 – PF after the Rally Finish.

15.3.2. Permitted early Check-in

An early check in is allowed for the following control points:

TC 1A – Parc Fermé B – In;

TC 1C – Flexi Service – Out / Parc Fermé B – In;

TC 3D – Parc Fermé C – In;

TC 7C – Rally Finish / Parc Fermé D – In.

15.4. ENTRY OF SERVICE VEHICLES

Service cars may enter the Service Park no later than one hour before the entry time of the 1st entered competing vehicle mentioned in the Time Schedule.

15.5. During the Rally, service vehicles must bear "SERVICE" plates. Vehicles without such stickers are not allowed to enter the Service Park. Inside of all Service Parks the staff charged by the Competitors/Crews must wear (in a very visible way) their bracelet (Color: ORANGE) supplied by the Organizer during the Collection of Documents and Materials

15.6. Displaying advertisement in Service Park out of designated surface for each Competitor/Crew is permitted only after receiving a written permission of the Organizer.

15.7. REFUELLING

15.7.1. Each Competitor / Crew is responsible for calculating the appropriate amount of fuel for his vehicle. In any case, the Competitor / Crew can't make claims against the organizer of the Rally if his vehicle does not cover the minimum distance between two refuelling points, indicated in the Itinerary and Road Book.

15.7.2. Any refueling activity is prohibited in the Service Park except dedicated Refueling Zones (if they are provided by the organizer).

Refueling is allowed at petrol stations located on the Rally route and indicated in the Road Book and in dedicated Refueling Zones on the SS route.

Only the crew members are authorised to do the refuelling on the petrol stations.

Each competitor must provide the required fuel by it's own in designated Refuelling Zones (RZ) and/or use only fuel available on commercial fuel stations indicated in the Road Book.

Any teams required to undergo final checks must immediately follow the instruction of the marshals in charge, even if this prevents them from proceeding to one or more time controls (TC). The complete original FIA homologation form, the FIA Passport and other necessary certifications must be available for final checks.

17. PRIZE GIVING CEREMONY

Prize giving ceremony will be held on 29.08.2021 / Sunday / from 14.30, after Regrouping Out TC 7B and before final Parc Ferme In TC 7C, in Szczecin-Dąbie Airfield, Przestrzenna street, 70-800 Szczecin.

Each Crew member is obliged to behave in a proper manner during the Rally, personally participate in the award ceremony and if receiving an award be clothed in sporting suit, i.e. overalls buttoned up and shoes complying with the provisions of automobile sport.

18. ENVIRONMENTAL PROTECTION

All the Competitors, Crew members, members of Competitors/Crew personnel and Competitors/Crews accompanying persons are required to obey the rules of PZM Environmental Code an especially use protective sheets against the destruction and pollution of the ground surface with petroleum materials.

Any maintenance work without the required protective sheets under the vehicle found by Organizer, would entail the imposition of a fine up to 100 % of required entry fee or other penalties by decision of the Stewards. Each case of behavior which is not in compliance with the PZM Environmental Code will be signalized to the Stewards.

19. ACCESS TO SZCZECIN

Planes

Szczecin is served by Szczecin-Goleniów "Solidarność" Airport which is 47 kilometers (29 miles) northeast of central Szczecin. It offers regular flights to cities in Poland and to international destinations (London, Liverpool, Dublin, Oslo, Edinburgh), as well as seasonal charter flights to other destinations. There is also a grass airstrip within city limits, the Szczecin-Dąbie Airstrip.

But the best flight connections are realized to / from the airports in Berlin. (BERLIN TEGEL and SCHONEFELD BERLIN). Transport to Szczecin provide taxi and shuttle companies.

Buses and Trams

There is a popular public transit system operating throughout Szczecin, including a bus network and electric trams, that is run by a number of companies.

Szczecin borders directly with the town of Police and is the urban center of the Szczecin agglomeration, that includes communities in the German states of Brandenburg and Mecklenburg-Vorpommern.

22.3 GENERAL FACTS ABOUT DRAWSKO POMORSKIE

Drawsko Pomorskie in northwestern Poland, the administrative seat of Drawsko County and the urban-rural commune of Gmina Drawsko Pomorskie. As of 2013, the town has 11,878 inhabitants.

Drawsko Pomorskie is located in the southeast of West Pomeranian Voivodship (since 1999) in the Farther Pomerania region, Drawsko is situated within the Pomeranian Lakeland, the western spur of the Baltic Uplands. The town lies on the headwater of the Drawa River, a right tributary of the Noteć, west of an expansive woodland with the protected area of the Drawsko Landscape Park. The regional capital Szczecin is about 100 km (62 mi) to the west. A large military training ground, located south of the town is frequently used in NATO exercises.

23. MILITARY TRAINING AREA

Part of the route of **2021 WYSOKA GRZĘDA BAJA POLAND** takes place on the military training area in Szczecin and Drawsko Pomorskie. These are strictly controlled military zones with special rules for usage and behavior.

The military training area of 12th Mechanized Brigade and CSWL Drawsko Pomorskie is a hospitable and highly respected partner of **2021 WYSOKA GRZĘDA BAJA POLAND** and organizer fully complies with the agreements and the requirements of the military training area and will NOT tolerate any infringement against the established rules.

WARNING:

1. Rally vehicles are NOT allowed to drive on the military training area except during the rally days.
2. Press vehicles are NOT allowed to drive on the military training area without special passes.
3. Service vehicles are NOT allowed to drive on the military training area except using the assigned routes by the organizer.
4. Spectators and other members of the teams are fully obliged to follow the orders of the organizer

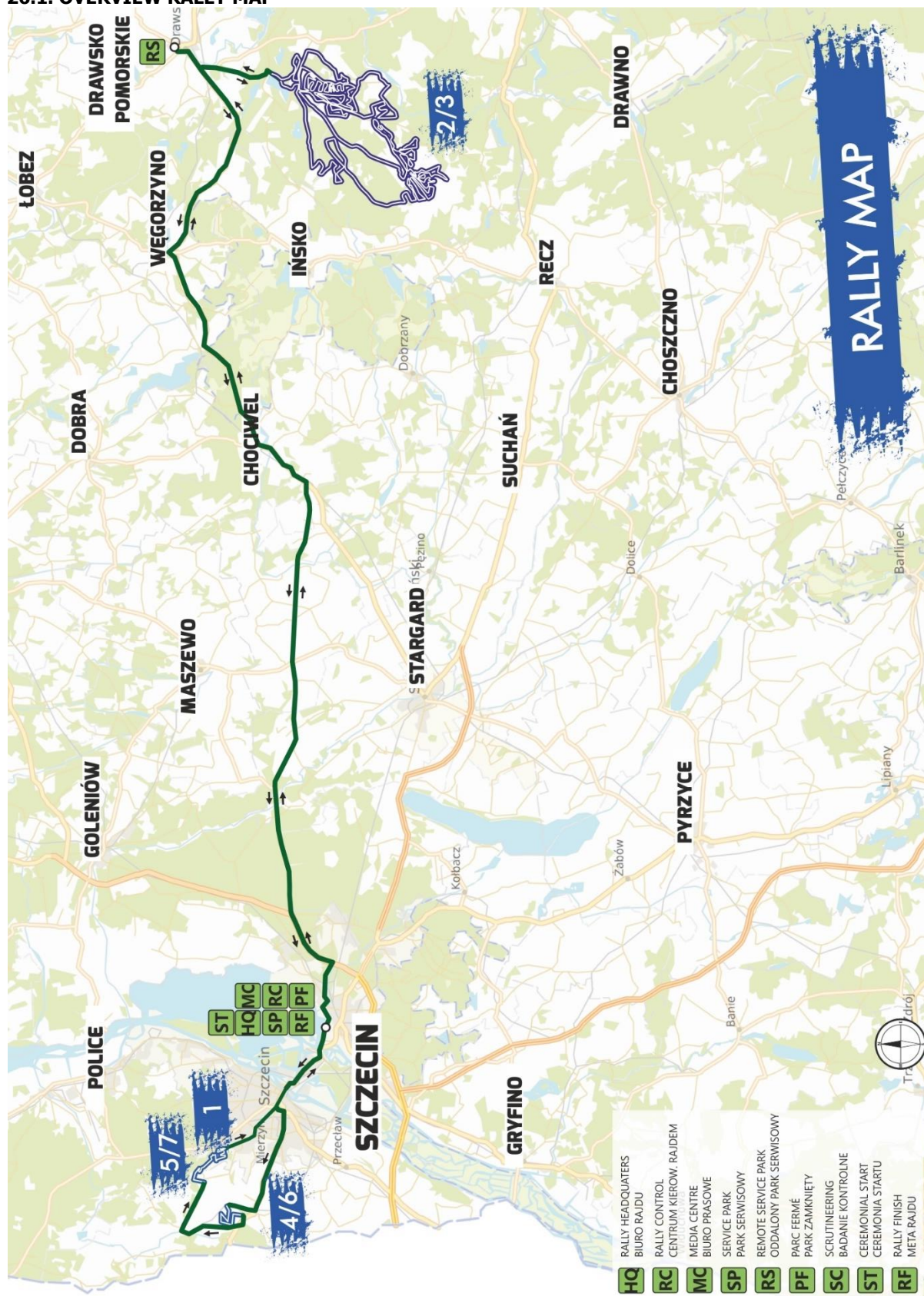

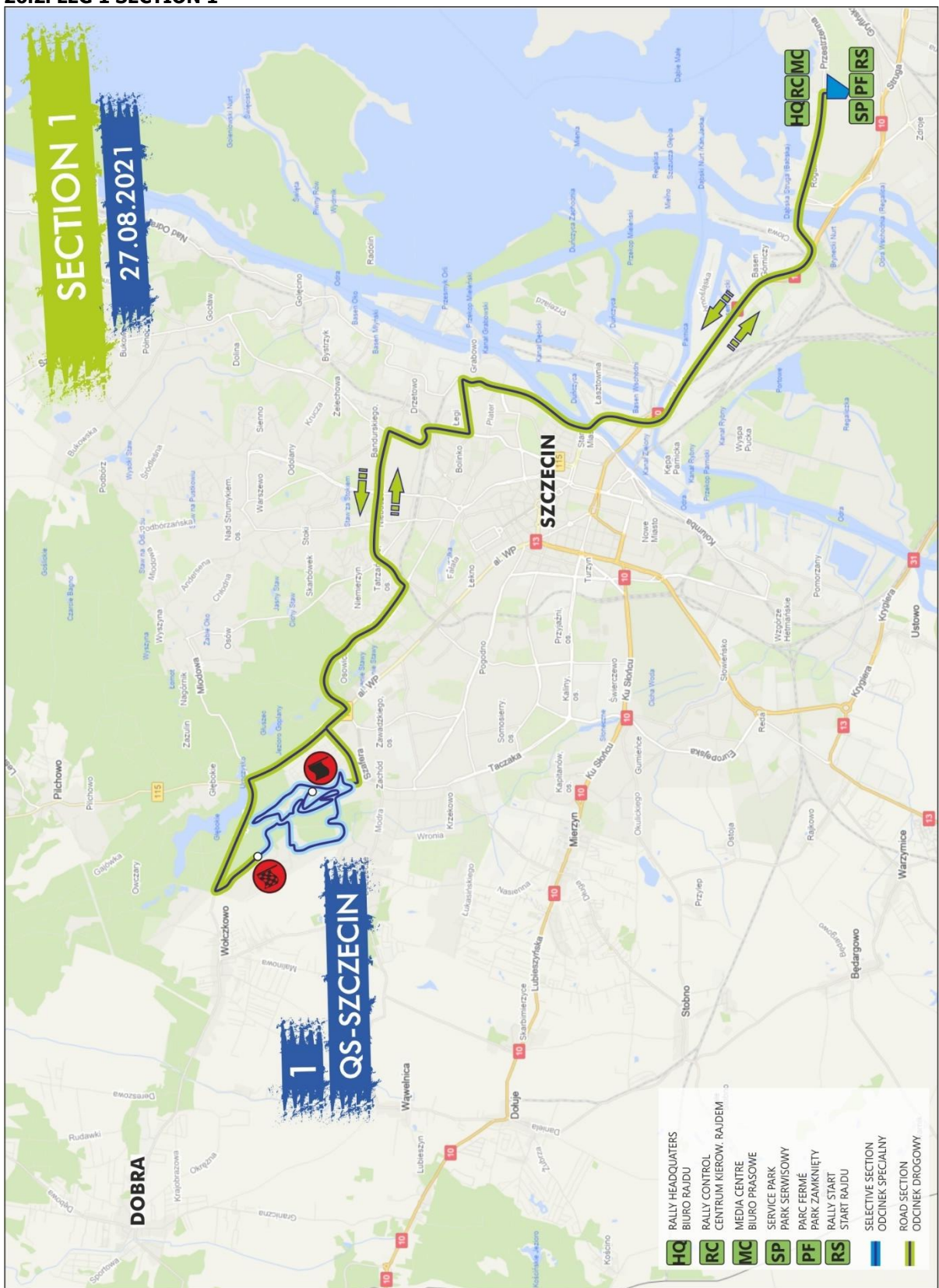

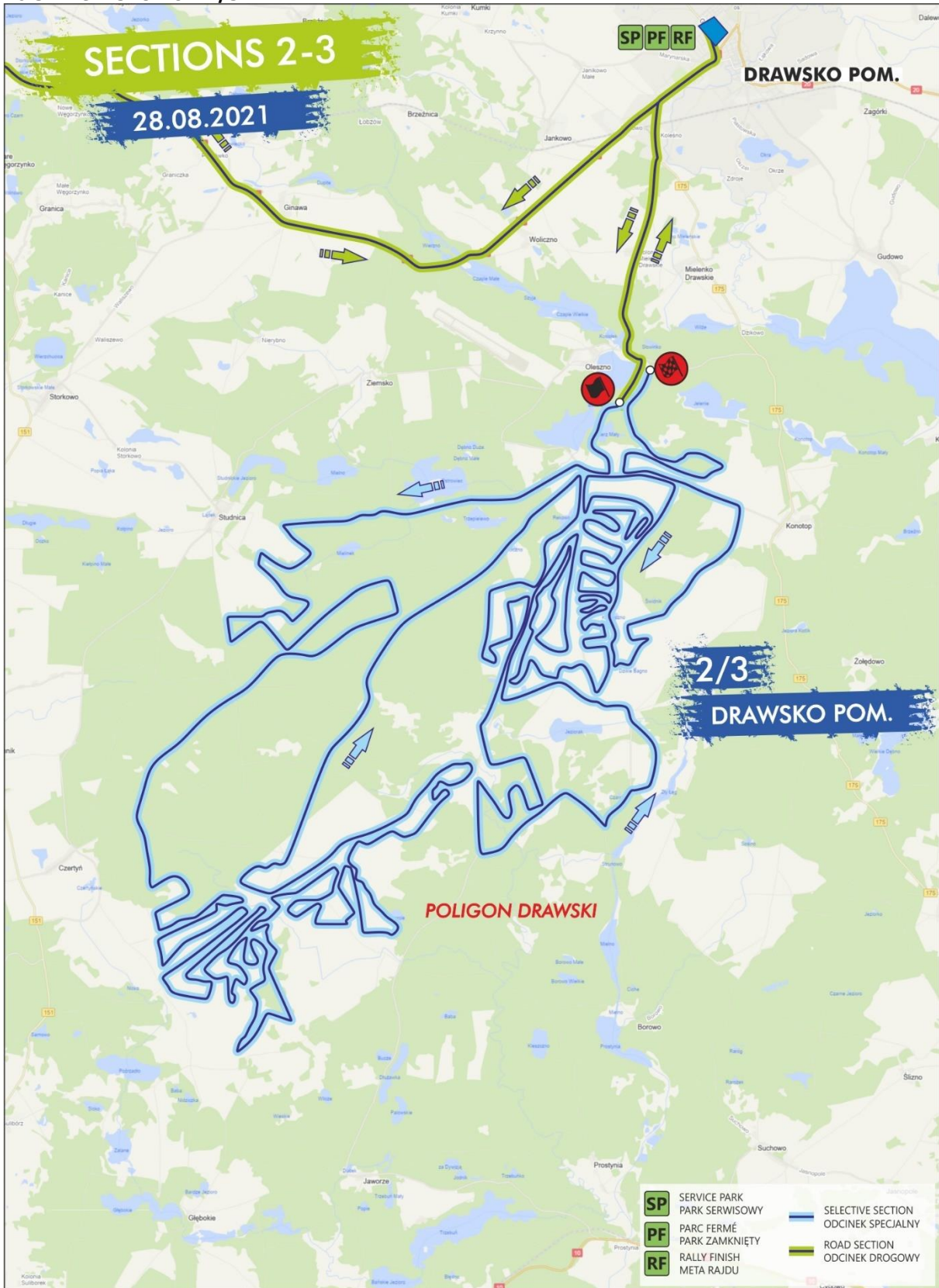
26.1. OVERVIEW RALLY MAP



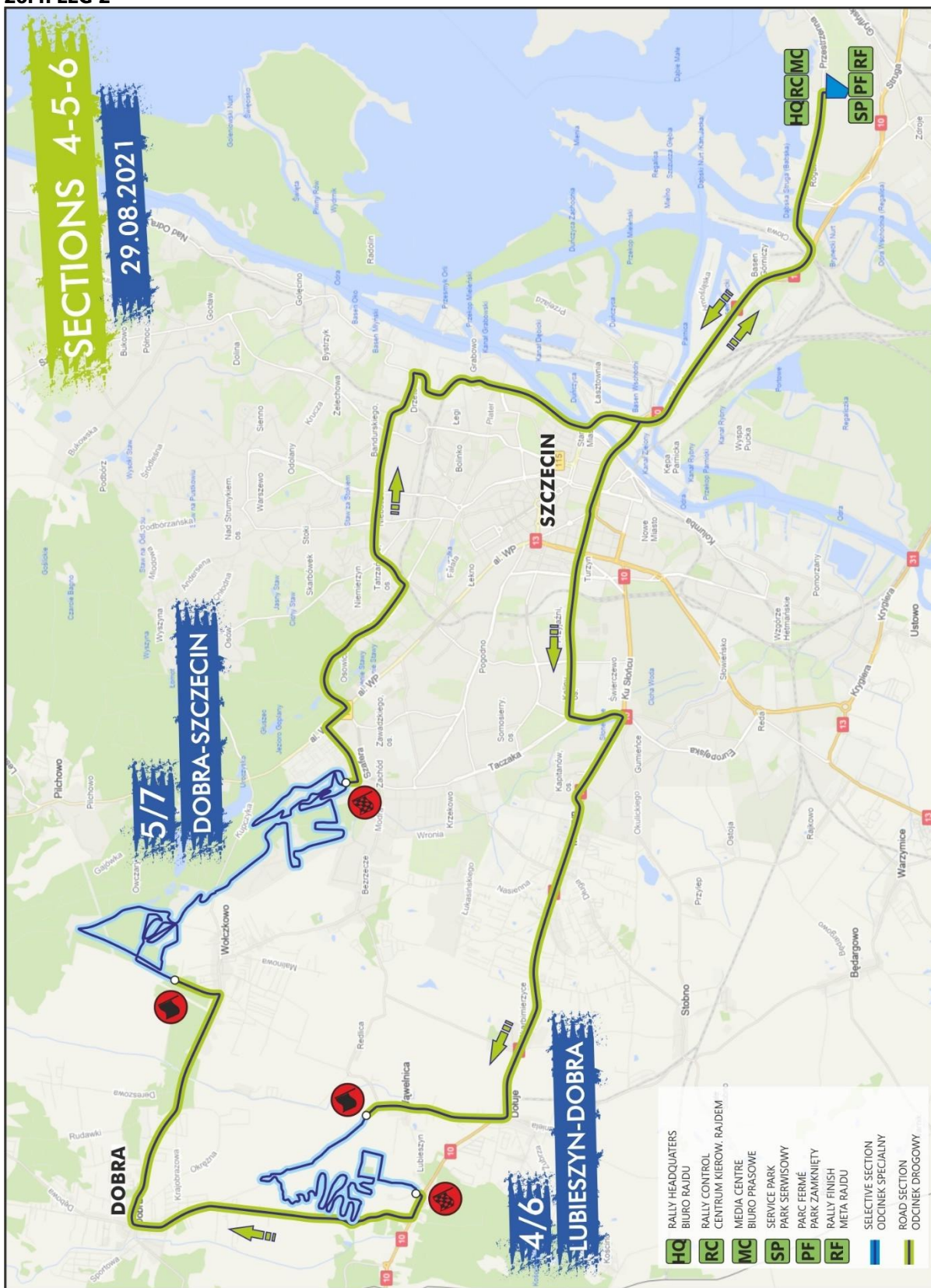
