4.6 Refunds

The entry fees will be fully refunded to the candidates whose entry has not been retained.

Refunds in case of "withdrawal":

The written declaration of the crew's withdrawal will be sent by email to the organizer (emilia.abel@ypresrally.com).

This declaration will include

- the justification of the withdrawal
- all the information necessary for the reimbursement.

An acknowledgement of receipt will be sent by the organizer to one of the crewmembers for confirmation.

If the withdrawal is declared before 15/06/2021 at 8 pm:

• the full refund of the entry fees will be made by the organizer within a maximum of 30 days after the end of the event.

If the written declaration of the crew's withdrawal is received after 15/06/2021 at 8 pm:

• a refund of 25% of the entry fee will be made by the organizer within a maximum of 30 days after the end of the event.

Refund in case of cancellation of the event due to "force majeure":

• The organizer will reimburse 90% of the entry fee, with an amount equivalent to 10% of the entry fee being retained for administrative costs.

5. Insurance

The organizer has contracted a civil liability insurance, in conformity with Article 21 of the RS BRC 2021, Chapter 2/2 of the National Sporting Regulations and the Belgian Law of November 21, 1989 - Art. 8, covering the civil liability of the competitors and crews mentioned by name (on the official list) and this only during the event and on the route of the rally, from the start of the first competitive element until the finish of the rally or until the moment of permanent abandonment or disqualification

5.1 Civil liability "Traffic".

Limits of coverage:

personal injury: unlimited per claim

Property damage: 100.000.000 € per claim (indexed)

A motor liability insurance is mandatory for all cars participating in the rally. As proof of liability insurance, an "International Motor Insurance Card" valid for Belgium (green or white) or another certificate attesting that the policy to which it refers meets the requirements of the law applicable in Belgium must be presented at the administrative control.

The routes of the connections are not covered in the civil liability insurance contract of the organizer. Assistance vehicles, auxiliary vehicles and reconnaissance vehicles are excluded from this coverage, even if they carry special plates issued by the organizer.

Civil liability "Organizer"

The Organizer has contracted an "Organizer Civil Liability Insurance" which covers damage to third parties, caused by an accident during the preparation, the conduct and the physical dismantling of the event and due to a fault of the organization.

Limits of coverage:

 bodily injury, material damage and consequential financial loss 	5.000.000 € per claim.
Excess for material damage:	125 € per claim
Legal protection:	15.000 € per claim

The Insured:

The organizer, the RACB, the officials, the Stewards, the members of the Red Cross or similar organizations, the members of the Civil Protection, the stewards, the participants, the intervention vehicles, and, in general, every person who participates in the organization of the rally.

5.2 Civil liability " Volunteers"

The Organizer has contracted a "Volunteer Civil Liability Insurance" which covers damages to third parties caused by the volunteers he calls upon, during their volunteer activity.

Limits of coverage:

bodily injury:	12.394.676,24 € per claim (indexed)
 property damage: 	619.733.81 € per claim (indexed)

5.3 Behaviour in case of accident (national road traffic regulations)

In case of an accident with only material damage, the competitor or his representative will have to declare it verbally at the next Time Control and in writing with a detailed report at the latest before the end of the Stage at the Race Direction Office to the Abandonment Officer, otherwise a fine of \in 500 is due. In addition, in case of bodily injury, the driver is obliged to inform immediately the qualified police authorities as well as the race HQ on the emergency number printed on the back of the logbooks. (Art. 53.3.8)

If a participating driver is involved during the rally in an accident in which a member of the public or any other person is injured, the driver and/or co-driver concerned must remain at the scene and stop the following car which must then report the accident at the next radio point indicated in the road book or at the next time control (road sector). (Article 53.4)

Hit and run is a correctional crime under Belgian law. Any competitor arrested by this procedure will receive a fair time in application of Art. 52 of the RS BRC 2021.

Safety and accident procedures for competitors will also be included in the Roadbook.

5.4 Breakdown service

To ensure safety, the car that fails to finish the special stage will be transported by the Organization to the end of the special stage or to a safe place for evacuation.

5.5 Waiver clause

The Organizer declines all responsibility in relation to the consequences of any infringement of the laws, regulations, and prescriptions in force in the country committed by the Drivers or Competitors. These consequences will be borne by the offender(s).

The Organizer also declines all responsibility in case of cataclysms, demonstrations, acts of vandalism, riots, assaults, sabotage, terrorism, natural disasters, etc. of which the Competitors, Drivers, team members or vehicle occupants could be the victims and of which the consequences (material, penal and sporting) will have to be assumed by themselves.

6. Advertising and identification

6.1 Mandatory advertising of the organizer

The organizer will provide each team with the competition numbers (67x17cm), which must be affixed on their car at the positions indicated before the technical scrutineering. Each panel must be placed horizontally at the leading edge of each front door, with the number at the front. The top of the plate must be between 7 cm and 10 cm below the lower limit of the window. It is not permitted to cut the sign.

6.2 Optional advertising by the organizer

Additional advertising by the organizer:

sticker in the middle of the rear window (30x10 cm): see addendum sticker on the roof after the front windscreen (10x10cm): see addendum sticker on the rear wings (10x25 cm): see addendum

6.3 Identification

The identification plates and competition numbers according to the specifications of Art. 27 and 29 of the RS BRC regulations will be issued by the organizer.

The plates and numbers will be affixed to the car before scrutineering and maintained throughout the event.

Any infringement of any rule concerning the identification plates and numbers will be sanctioned as follows

- absence of only one Rally Plate or Competition Number: 100 € fine
- simultaneous absence of numbers and/or rally plates: disqualification

- rally plate invisible or partially covering the registration: fine of 100 \in .
- absence of an optional advertising of the organizer at any time: payment of the entry fees without advertising

6.4 Assistance vehicles

The stickers of the assistance plates, auxiliary plates and any other vehicle pass must be applied in the upper right corner (seen from the inside) of the front windscreen.

7. Tires

7.1 Regulations concerning the tires that may be used during the rally

See Art. 13 of the RS BRC.

7.2 Tires for recce

Only commercial tires approved for road use (asphalt) are allowed.

7.3 Quantity of tires

The cars in the Historic Belgium Championship 2021 have a free choice of tires but must have the marking "E" or "D".

8. Fuel

8.1 Fuel types

All fuel types must comply with Art. 62.1 of the RS BRC. **Refueling Zone: All competitors may only refuel in the refueling zone.**

(See road book).

9. Reconnaissance of Special Events

The recce is in accordance with Art. 35 of the RS BRC. The schedule of recce is published in Appendix 2 of these special regulations.

9.1 Registration procedure

The registration for the reconnaissance is obligatory and will take place during the distribution of the roadbooks.

Recce registration form

The reconnaissance registration form will be available at the same time as the registration form on the website www.ypresrally.com " Competitors " " Recognition ".

This form, duly completed, must be returned no later than June 26, 2021 by email, or when the road books are distributed.

When a competitor's reconnaissance car must be replaced for any reason, the competitor must notify the Course Direction and provide details of the replacement car. The reconnaissance sticker must be placed on the replacement car.

9.2 Specific restrictions

During the reconnaissance, the Trafic Code must be respected, especially the speed limits. Please note that the special stages will be open to public traffic during the reconnaissance. The organizer may reduce the speed limit individually by marking the areas in the roadbook and along the course.

Any speeding during a reconnaissance will result in a fine applied by the Race Director in accordance with Art. 34.2 of the RS BRC.

Passages

Crews can only do a maximum of 2 passages on each special stage according to the timetable indicated in Appendix 2. Passages must be conducted in the same direction as the rally, at a reduced speed and in full respect of the Highway Code. Special stages that take place several times during the rally are considered as one special stage during the reconnaissance.

11. Technical checks, seals and markings (on invitation)

Each competitor who wants to participate in the South Belgium Rally and also in the Ypres Historic Rally with the same car should only pass once the technical control of the RACB in Vresse. The technical scrutineering of the "South Belgium Rally 2021" will also be valid for the "Ypres Historic Rally 2021". The competitor in question should not make the ceremonial start on Saturday evening and must present himself directly at the TC0 - Parc Fermé OUT Ypres ten minutes before the time indicated on the start list of the "Ypres Historic Rally 2021".

Cars can be presented to the technical control by a team representative. See program (RP Art. 3). The schedule for the presentation of the additional pop off valves will be published on the TOAV of the official website of the rally www.ypresrally.com. Location of scrutineering and schedule

The program will be given to each crew when the material and documents are distributed.

11.1. Technical checks, compulsory documents

The certified homologation form SOS / OK board (DIN A3 format)

11.2. Safety equipment of the pilots

All clothing, including helmets and RFT's intended to be used, must be presented at the technical checks. They must be checked for compliance with the requirements of Appendix L, Chapter III of the ISC.

11.3.Noise level

The permissible noise level on the connecting sectors is 95 dBA. If a vehicle does not comply with this rule, the start of the crew concerned will be refused. The noise level is measured with a sound level meter regulated at " A " and " SLOW " placed at an angle of 45 degrees and 50 cm from the exhaust pipe with an engine speed of 3500 rpm.

11.4. Special national requirements

Cars registered in Belgium must have a certificate from the Belgian Motor Vehicle Inspection; Each car must be equipped with a red reflective triangle, 2 safety vests and a first aid kit according to the European Highway Code.

2 seatbelt cutters must be on board at all times. They must be easily accessible for the pilot and copilot sitting in their seats, with their belts fastened.

11.5.Installation of Safety Tracking System (STS) Pickup / distribution

All cars must be equipped with a Geo Dynamics system provided by the organizer. The SSS devices will be distributed at the technical control against the deposit of a credit card guarantee refundable upon their return, in good condition and within the time limit. The procedure and the necessary technical requirements will be specified in an addendum. The team/crew that has installed the equipment incorrectly must do so correctly before the start of the rally.

Any damage, loss, deterioration, or theft of the tracking system remains the responsibility of the team until it is returned in accordance with the regulations, even in the case of a run-off, abandonment, disqualification or any other race-related event.

11.6.Return equipment

The complete STS equipment kit will be dismantled by the organizer in the Parc fermé at the end of the rally.

In case of withdrawal or premature abandonment, the competitor must return the complete SSS kit to the rally HQ Ouderdomseweg 9B, 8970 Poperinge during the opening hours.

12. Other procedures and regulations

12.1 Starting Ceremony and Starting Order

There is a start ceremony.

The start of the rally will take place on 27 June at 07:05 at the CH0 Start located in Ypres, Podium Grote Markt

The starting order and intervals throughout the rally will be in accordance with the RS BRC, Art. 41.5. All cars will start with an interval of one minute.

Start times will be published on ONB and DONB on 26 June at 18:00

12.2 Starting area

The start area must be considered as a Media area. No assistance is allowed in the start area. Finish procedure

After the podium in Ypres, all crews must follow the instructions of the officials on site to proceed to the Finish Podium.

12.3 Finish Procedure

After the Finish Podium ceremony, the cars will proceed to the Closed Holding Area under the control of the Organiser.

Selected rally cars will be escorted to final scrutineering and/or proceed to the final Parc Fermé. The Parc Fermé regime will be controlled by the Organisers.

12.3.1 Early check-in allowed

Crews are allowed to clock in early, without incurring a penalty, at: CH 1A, 4A, 7A and TC11A.

12.4 Special procedures and activities

Availability of participants

Participants who park their vehicle in the Parc fermé after crossing the finish line must remain available by mobile phone until the final classification is published.

Classification

The final classification will not be distributed after the rally. The final classification will be published on the ONB and DONB of the official rally website (www.ypresrally.com).

Crew safety

All competitors are asked to pay particular attention to Art. 53 of the RS BRC.

Crew contact number

At the administrative checks, all crews will be required to communicate the number of the mobile phone they will use and keep connected in the car throughout the rally, or which they will connect within 30 seconds of stopping their car during a special stage. This is part of the crew safety procedures of the event's Safety Plan.

A TEAM mobile phone number (assistance) must also be declared.

Other points

Opening cars are forbidden.

Tyre and brake warm-ups

For reasons of public safety during the access to the Special Events, it will be forbidden to warm up the tyres and brakes by driving in a dangerous way on the public road or by swerving.

Any infringement will be reported immediately to the Stewards of the Course.

Speeding

Fact Judges (ISC Art. 11.16) will be in charge of checking the respect of all the prescriptions concerning the rules of assistance and the Assistance Park. Particular attention will be paid to the respect of the speed limits (30 km/h) in the Service Park and (5 km/h) in the Feed Zone (Art. 49.4). Any infringement will be reported to the Stewards.

Service park

The Service Park will be located in: Poperinge, Vlaanderenlaan

The reservation of the service area can only be done on www.ypresrally.com " Competitors " " Service park ", before June 23rd 12:00.

All teams will have to provide an operational fire extinguisher of minimum 6kg, visibly positioned in the service area, and this, during the time necessary for all interventions on the car. The use of a ground sheet is mandatory

No storage of fuel of any kind will be allowed in the service park and in the service areas, as **well as** in the service vehicles or/and auxiliary vehicles. The confiscation of fuel will be accompanied by a fine of 500 € imposed by the race director. The access and circulation of a vehicle carrying fuel in the service park is strictly forbidden. Only a maximum quantity of 20 litres of fuel necessary to fill the tanks for the equipment (generator, heating, etc) will be tolerated.

On-board cameras

- If requested by the Organiser and/or promoter, the competitor shall install an on-board camera or other recording equipment. The Organiser will make the installation with the approval of the Technical Delegate.

Any competitor whose car is equipped with an on-board camera must obtain prior authorisation from the promoter. Authorised cameras will be identified by a sticker and must already be installed in the car at the time of scrutineering.

On-board camera recordings may only be exchanged in the support areas. Any other location will require the prior approval of the Course Direction.

Media zones

A "Media Zone" will be set up in the Regroup before the Service Parc. Access to this Media Zone will

be limited to persons in possession of the appropriate pass.

Removal of cars from the Parc Fermé at the end of the rally

After the Stewards have authorised the opening of the Parc Fermé at the end of the rally, the **cars** may be removed.

Provided that this is done according to the programme, all cars must be removed before 27 June 21:00.




19. Appendix 4 - Stickers and additional advertising

20. Appendix 5 - Support fleet

General conditions

Article 57 of the Sporting Regulations of the Belgian Rally Championship of RACB Sport is strictly applicable.

Locations :

Service park :

Location: Entrance via Vlamingenstraat, (Frankrijklaan side) Poperinge Trailer parking :

Location: Ring Poperinge (Noordlaan, Oostlaan, Zuidlaan, Westlaan).

In the service park it is forbidden to park trailers under penalty of 125euro.

Timetable :

Access to the service park for installation: 26 June 2021, from 14:00.

Exit from the service park: 27 June 2021, from 21:00

The circulation of assistance vehicles is forbidden during the passage of the competitors.

However, in case of abandonment or disqualification, the "SERVICE" vehicles concerned may

leave the service park with the permission of the service park manager.

They may not - under any circumstances - constitute a hindrance to competitors still racing. Reservation of service pitches :

Requests to reserve pitches will only be registered via www.ypresrally.com " Competitors " " Service park ", by 20 June at 12:00

Dimensions :

Each competitor will be allocated a pitch with a frontage of 8 metres.

If a "team" provides assistance to several cars, it will benefit from an additional space of 5 metres per additional vehicle (i.e.: 13 metres for 2 cars, 18 metres for 3 cars, ...).

Location:

The organiser will mark out and number the service areas.

The organiser will inform each competitor of the location of his "service area" when the material and documents are distributed:

Any installation that does not respect the dimensions and location of the assistance area assigned by the organisation will be dismantled and removed at the competitor's expense.

Cleanliness

In the service park, it is compulsory to use the bins and containers provided for this purpose by the organisation.

It is forbidden to throw tyres or pieces of glass into these containers.

Fire prevention

In accordance with the provisions of the municipal fire prevention regulations:

It is forbidden to use heating installations and cooking appliances with "live flames". This includes "camping gas", barbecues, etc.

The use of gas cylinders is PROHIBITED

During any assistance, the use of a ground sheet is compulsory as well as the presence of an operational fire extinguisher of 6 kg, visibly positioned, is compulsory on each assistance stand. Any infringement will be reported to the Commissaires.

Music broadcasting

The organisation will not be held responsible for the broadcasting of music - for private use - in the service park.

Each competitor will have to comply with the Belgian legislation (SABAM, "equitable remuneration", etc.) concerning the broadcasting of music in a place accessible to the public.

Electricity

The organisation does not foresee any electricity supply or earthing in the service park.
