The Stewards, having become aware that car No. 8 did not follow the Road Book itinerary between the Stop Control of SS9 and TC9A, summoned the above competitor's representative, have considered the following matter and determine the following:

Facts The crew of car No. 8 did not follow the Road Book itinerary as indicated in Bulletin No. 2 point 3 – Attachment 5

Offence Breach of Art. 19.2 of the 2022 FIA WRC Sporting Regulations, in conjunction with Bulletin No. 2 – Attachment 5.

Decision Driver OTT TÄNAK and Co-driver MARTIN JÄRVEOJA shall be jointly and severally liable to pay a **fine of € 1000**.

Reason A hearing was held on Sunday, 5th June 2022 at 09.50 hrs with the Team Manager, Mr. Pablo Marcos.

Mr. Marcos explained that after the cancellation of SS 8 and SS 9, car No. 8 did not need to refuel at RZ 5 because they were able to reach the RZ 6 on Saturday after Service C (at the beginning of Section 6).

He apologised for this lapse but he did not think that not following the itinerary (for approximately 500 m) as indicated in Bulletin No. 2 only to reach the RZ 5 could be considered as a breach of the regulations.

Art. 19.2 of 2022 FIA WRC Sporting Regulations stipulates that "*All crews will receive a road book containing a detailed description of the compulsory itinerary which must be followed*".


The deviation of the road itinerary mentioned in Bulletin No. 2 for the crews using the FIA fuel was clearly explained.

The Stewards therefore concluded that the crew of car No. 8 was in breach of the above regulations and the penalty imposed is proportional under the above-mentioned circumstances.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2022 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
