1. Please note the following change of officials from the published Regulations, Motorsport Ireland Steward will now be replaced by Adrian Cronin.
2. Please note, the Club Appointed Steward for the event was omitted from the list of Officials, Alan G. Verso will officiate as Club Appointed Steward for the event.
3. Please Note, Micheal Linehan is the appointed ITRC Eligibility Technical Delegate for the event and will be carrying out compliance spot checks throughout the event.
4. Reconnaissance Sign-On is based in the Event HQ, Radisson Blu Hotel, Little Island, Co.Cork on the following dates and times:
 - Saturday 23rd July '22 @ 08:00 to 12:00 in Rally HQ
 - Sunday 24th July '22 @ 08:00 to 12:00 in Rally HQ
 - Thursday 28th July '22 @ 08:00 to 12:00 in Rally HQ
 - Friday 29th July '22 @ 08:00 to 12:00 in Rally HQ
5. Competitors, please bring your competition licence to Reece Sign On where your licence will be checked, this will assist the rally office personnel greatly speed up documentation scrutiny.
6. Reece will only be permitted at the following times:
 - Saturday 23rd July '22 @ 09:00 to 18:00 in Rally HQ
 - Sunday 24th July '22 @ 09:00 to 18:00 in Rally HQ
 - Thursday 28th July '22 @ 09:00 to 18:00 in Rally HQ
 - Friday 29th July '22 @ 09:00 to 18:00 in Rally HQCompetitors are reminded to refer to the event regulations with regards the number of passes permitted over each stage.
7. Reece Stickers **must** be displayed prominently on cars at all times – this will be monitored for compliance.

8. Speed Limit on stages for reece is 60kph. Please note there will be random speed checks on the route. **DO NOT IGNORE!!**. Please respect local residents. Penalties will be applied for breach of compliance. Please drive carefully as Garda speed checks will also be in place along the route.

9. THE USE OF CHASE CARS IS STRICTLY FORBIDDEN AND WILL BE STRICTLY MONITORED. PENALTIES WILL APPLY. THERE WILL BE NO EXCEPTION TO THIS RULE

Competitors are reminded that no outside assistance is allowed (other than to re-join a stage). Servicing will only be permitted within the service park as defined in the event roadbook. Each Stage exit will be continuously monitored for team vehicles and if team vehicles are found to be in the area of stage exits, penalties will be applied.

Please note that all named officials published in the event regulations will act as judge of facts for all elements of the event along with the following personnel. Alan G. Verso, Pat Cahill, Raymond J Verso, Noel Gough, Gavin Walsh, Don Montgomery, Frank O'Mahony, Emmet Cronin, Ger Hayes, Declan O'Leary, Sean Daly, Greg McCarthy, Ciara Murphy.

10. Please note the following changes from the issued details on the event regulations:

- Trailer Park will be located at the Old Mitsui Site, Little Island, Co.Cork.
(Coordinates: N 51° 53.989' W 08° 22.168')
- Article 15.1: Competitors selected for final scrutineering checks will be notified at the final control, those requested to attend the finish ramp will be notified at the finish ramp. Final Checks will be carried out at the pre-event scrutiny location.
- Approved Clothing Types: Refer to FIA Appendix L
- Junior Regulations: Article 3 – Eligible Vehicles: **ALL** cars must comply with current M.I. Class 16 Regulations – no exceptions.
- Mechanical Scrutineering: will take place between **13:00 – 18:30**, 29th July 2022.

11. Mechanical Scrutineering:

- Mechanical Scrutiny will take place Fota Point, Cobh Cross Industrial Estate, T45 FE81
(Coordinates: 51.908588, -8.290236)
- Only 2 persons per car maximum can attend scrutiny.
- Safety Tracking Systems (STS) can be collected at Mechanical Scutiny in advance of completing mechanical scrutiny and **MUST** be fitted to the car before attending mechanical scrutiny.
- Competitors are requested to attend documentation scrutiny promptly, no later than 30mins after completing mechanical scrutiny so as to avoid lengthy delays.

12. Parc Ferme is in the same location as the Trailer Park, Old Mitsui Site, Little Island, Co.Cork. The route to Parc Ferme will be arrowed from Scrutiny. **(Coordinates: N 51° 53.989' W 08° 22.168')**

Competitors are reminded that carrying out of any works on cars within parc ferme is strictly prohibited. **All Cars must be in Parc Ferme by 21:30 Friday 29th July 2022**

13. A competitor safety briefing will be conducted in the Rally HQ on Saturday 30th July 2022 at 07:30am, in the main function room behind reception, attendance at the safety briefing is mandatory for all crews and a random roll call will be conducted.

14. It is the onus of the competitors, in particular overseas crews to ensure and familiarise themselves with the scrutiny requirements for Irish events and check the relevant IRDS / BRDS Insurance and ensure they are on the current IRDS / BRDS Database.
15. Access to the Cork Marts Service Park for service crews and service barges will be available from 17:00 on Friday 29th July 2022. Strictly **NO** parking on grass verges in service park & please do not interfere with fire hydrants in service park. There are no trailers allowed in the **servicing area** of the service area – **please obey this request**.
16. Competitors and Service Crews **MUST** remove all litter from the service area. Skips will be provided in the service area – **PLEASE USE THEM** – Should Service Crews ignore this instruction, penalties may be applied to the relevant competitors at the discretion of the organisers.
17. Refuel Zone: the event will have a dedicated refuel zone based after the Service Out Control in the service park, strictly no re-fuelling will be allowed within the main service area – this will be strictly monitored for compliance. Competitors are reminded to read Art. 12.7 of the Supplementary Regulations. Crew must exit the car during the refuelling process. **Strictly** no smoking or use of mobile phones are permitted within the refuel zone. Access to the Service Park Refuel Zone is restricted and access permitted only by official wristband – no exceptions.
18. All Service Crews must have and use non-porous ground sheets. If your service crew does not adhere to this instruction they will not be permitted in the service area. Failure to comply with instruction may result in penalties being applied.
19. Competitors are reminded of the following service park rules:
 - The Service Area is a **NO SMOKING AREA** for the duration of the event and competitors are reminded of the Motorsport Ireland protocols in relation to rally service areas.
20. **Super Rally:** The event will have available to competitors Super Rally regulations. Please ensure you read and fully understand the rules and regulations of re-joining under Super Rally regulations – please refer to relevant section of the regulations. A dedicated Super Rally coordinator has been appointed to assist and monitor compliance with the re-start procedures. Winnie Sheil +353 (87) 6209312 is the nominated coordinator and all enquires / re-start requests are to be directed to him.
21. The event Scrutineers will be carrying out spot checks at stage starts and will pay particular attention to the proper fastening of safety harnesses and wearing of Hans Devices.
22. The onus is on competitors to ensure they are entered in the correct class.
23. Reminder – all competing cars are required to enter and remain in Parc Ferme for 30minutes after their “scheduled time in” at the conclusion of the event.
24. Pacenotes for the event are available through the usual 3rd party providers, the organisers has no involvement with their preparation or sale and accepts no responsibility for their accuracy or otherwise.

Important: You are rallying on closed public roads with the goodwill of the residents if you ignore instruction no. 7, all our rallying days could end.

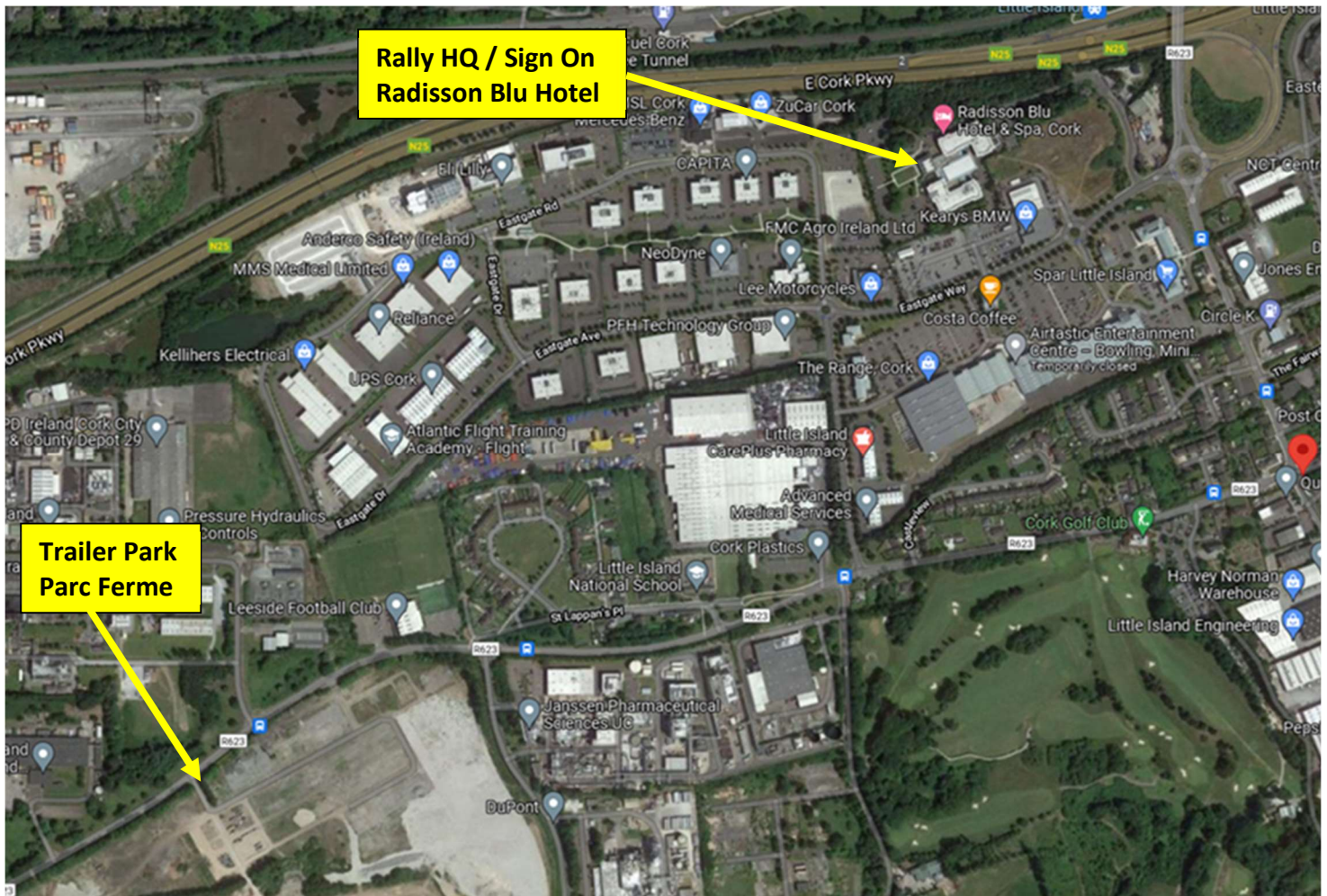
