The Stewards, having received a report from the Technical Delegate, summoned and heard the team representative, Mr. Lorenzon Filippo (Individual Communication No 3, Doc. No. 4.3), have considered the following matter, determine the following:

**Fact:** Car # 31 did not pass through and stop in the tyre marking zone in Section 3

**Offence:** Breach of FIA Regional Rally Sporting Regulations (RRSR) Art. 13.8

**Decision:** **250 € fine**

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason:** Mr. Filippo explained that since the crew retired yesterday in Section 2 there was enough fuel in the tank, so the crew past through the refuelling zone and has forgotten to pass through the tyre marking zone and thus did not stop there. In the meantime the crew retired in SS 8 and will not finish the rally.

For checking and marking the tyres the crew must pass through the tyre marking zone and has to stop its car and wait for the instructions of the scrutineers and/or marshal. Since car # 31 did not pass through this zone and stopped it is a breach of regulations.

The Stewards conclude the crews followed in section 1 and 2 the regulation regarding the tyre marking and since the crews retired from the rally and time penalty is not appropriate for this infringement and decided for a fine.

This decision is not precedent for cases of infringement of the tyre marking regulations.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
