The Stewards, having received a report from the FIA Media Delegate, summoned the above driver as well as a competitor's representative, have considered the following matter and determine the following:

Facts The Driver KAJETAN KAJETANOWICZ did not attend the Post-Rally Press Conference

Offence Breach of 2022 FIA WRC Sporting Regulation Article 38.2

Decision a) To impose a **Reprimand** on Driver KAJETAN KAJETANOWICZ
b) To impose a **Fine of € 3000** on the Driver. This fine is being applied with suspension of sentence subject to no further breach of Article 38 of the 2022 FIA WRC Sporting Regulation (Promotional Activities) – at any FIA WRC event during the 2022 season


Reason The Stewards heard from the Driver, Mr. Kajetan Kajetanowicz (via phone), and competitor's representative, Mr. Pavel Kajzar (physically present), in the presence of the FIA Media Delegate, Ms. Vera Dussausaye.

The Driver stated that he had to travel to the airport to catch a flight later this evening. The Driver was apologetic and stated that he understands these media obligations are not only for himself as a professional priority driver but more importantly for his team, sponsors, organisers, the WRC, the FIA and the sport. The Driver promised the Stewards that he will commit to future media commitments and obligations.

The Stewards wish to highlight the importance of media obligations and promotional activities that are, in most circumstances, pre-scheduled, coordinated and organized with the drivers, co-drivers, and team personnel. The series of sub-articles under Article 38 of the 2022 FIA WRC Sporting Regulation clearly state and bind drivers, co-drivers and team personnel to Promotional Obligations during a rally and are set forth in a manner where failure to attend may result in sanctions and penalties by the Stewards.

The Stewards, having reviewed the Driver's record, find that he has been cooperative in the past and see that this is the Driver's first recorded unexcused absence of a pre-scheduled press conference. The Stewards conclude that a suspended fine is justified.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2022 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
