The Stewards, having received a report from FIA Technical Delegate (document No 6.1), having summoned and heard the team representative Egor Okhotnikov (summons No 7), have considered the following matter, determine the following:

Crew and car No: Sergey Remennik, Jaroslav Fedorov, Car No 404

Competitor: Snag Racing Team

Time: 11:00 hrs, Friday, 11 February 2022

Session: Pre – event scrutineering

Fact: Competitor could not provide the original documents for the safety cage

for Car No 404

Offense: Breach of Article 25.3.1 of 2022 FIA Cross-Country Rally Sporting

Regulations

Decision: To impose a fine of 500 Euro to Snag Racing Team.

In accordance with the Art.12.7 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason:

The representative was not able to provide the original documents and explained that the owner of the team and the car will provide the original documents not later than Saturday, 12th February at 09:30.

The Stewards conclude that in this case the infringement of the rules has already been found during pre-event inspections. The subsequent presentation of the original documents, although not in line with the requirements of the rules, could be taken into account by the Stewards when imposing a penalty. However, the competitor did not present the original documents by the deadline specified by them.

According to the article 25.3.1 of the 2022 FIA Cross-Country Rally Sporting Regulations, the competitor is responsible for the technical conformity of his vehicle throughout the event and should be able to provide any related official document.

The Stewards conclude that it is the responsibility of the competitor to provide the original documents for the safety cage.

The Decision is based on the FIA International Sporting Code Art. 11.9.1; Art. 11.9.3.a, Art. 11.9.3.f and Art. 12.4.1.c.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
