The Stewards, having received a report from FIA Technical Delegate (document No 6.1), having summoned and heard the driver and the co-driver (summons No 6), have considered the following matter, determine the following:

Competitor: Tomasz Bialkowski

Session: Pre – event scrutineering

Fact: Competitor could not provide the original documents for the safety cage

for car No 401

Offence: Breach of Article 25.3.1 of 2022 FIA Cross-Country Rally Sporting

Regulations

Decision: To impose a fine of 500 Euro to Competitor Tomasz Bialkowski.

In accordance with the Art.12.7 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason:

The competitor explained that he bought the safety cage about one month ago. Due to the Covid pandemic the manufacturer was not able to provide the original documents for this safety cage to the competitor until today. They have received only a copy via email today.

According to the article 25.3.1 of the 2022 FIA Cross-Country Rally Sporting Regulations, the competitor is responsible for the technical conformity of his vehicle throughout the event and should be able to provide any related official document.

The Stewards conclude that it is the responsibility of the competitor to provide the original documents for the safety cage.

The Decision is based on the FIA International Sporting Code Art. 11.9.1; Art. 11.9.3.a, Art. 12.4.1.c.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
