The Stewards, having received a report from FIA Technical Delegate (document No 6.1), having summoned and heard the co-driver Egor Okhotnikov (summons No 5), have considered the following matter, determine the following:

**Crew and Car No:** Saleh Alsaif, Egor Okhotnikov, Car No 208

**Competitor:** Snag Racing Team

**Time:** 11:00, hrs Friday, 11 February 2022

**Session:** Pre – event scrutineering

**Fact:** The FIA Sticker is missing which identify the vehicle.

**Offence:** Art. 8.3 of the 2022 FIA Cross-Country Rally Sporting Regulations.

**Decision:** To impose a fine of 500 Euro to Snag Racing Team

In accordance with the Art.12.7 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason:**

The co-driver explained that he does not know why there is no sticker on the safety cage. Due to the fact that this is an old car, the safety cage was new painted. By doing this, the sticker was not protected. He admitted that it is the competitors responsibility to present the vehicle with the appropriate seals.

Having considered the matter and the above mentioned article of the 2022 FIA Cross-Country Rally Sporting Regulations, the Stewards determined that the car presented to pre-event scrutineering was not in compliance with the regulations.

The Decision is based on the FIA International Sporting Code Art. 11.9.1; Art. 11.9.3.a, Art. 12.4.1.c.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
