The Stewards, having received a report from the Clerk of the Course and having examined the evidence (the report and subsequent pictures and physical evidence), summoned, and heard from the team representatives, have considered the following matter, determine the following:

**Fact 1:** The team was found to have positioned a vehicle with service stickers (car 25) on the liaison section between TC 7 / 9 and TC 9 / 10.

**Fact 2:** The said vehicle was carrying Avgas fuel (11 bottles x 1.5litre) in normal plastic water bottles, which is extremely hazardous and dangerous.

**Fact 3:** The Team has registered under the AAT team awards; therefore, the service sticker is irrelevant.

**Fact 4:** upon summons and hearing their case, the reasoning given were different from all, which doesn't had clarity to the why the motor vehicle was positioned on the location.

**Fact 5:** The communication via sms to the ASN Steward threatening legal action, by the family of the team entered.

**Offence:**

1. Breach of Article 56.1.1 of the 2022 FIA Regional Rally Sporting Regulations, which states as follows:

*From the first TC onwards, service of a competing car may be carried out ONLY in service parks and as permitted under Article 60 with the exception of repairs to retired cars intending to re-start.*

2. Breach of Article 12.1.1.a of the 2022 FIA International Sporting Code, which states as follows:

*Unless stated otherwise, offences or infringements are punishable, whether they were committed intentionally or through negligence.*

3. Breach of Article 12.1.1.b of the 2022 FIA International Sporting Code, which states as follows:

*Attempts to commit offences or infringements are also punishable.*

4. Breach of Article 12.1.1.c of the FIA International Sporting Code, which states as follows:

*Any natural or legal person who takes part in an offence or infringement, whether as instigator or as an accomplice, is also punishable.*



5. Breach of Article 22.5 of the 2022 FIA Regional Rally Sporting Regulations, which state as follows:

*By the very fact of signing the entry form, the competitor and crew submit themselves to the sporting jurisdictions specified in the Code and its appendices, these Regulations, and the Supplementary Regulations of the rally.*

**Decision: DISQUALIFICATION.**

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits

**In application of Article 12.2.3.b of the FIA International Sporting Code, this Decision becomes immediately binding even in the event of an appeal as it concerns a question of good conduct.**
