The Stewards, having received a report from the COVID-19 Delegate summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts Hyundai Motorsport N did not declare or question their crew about possible close contacts to a positive COVID-19 case before attending the Portugal Event.

Offence Infringement of the 2021 FIA International Sporting Code Appendix S, Art 2.1 and Art. 6.6 and Art. 6.8.

Decision Reprimand.

Reason The Stewards heard from the crew of car 27 (by video link), from the competitor's representative, Mr. Andrea ADAMO, Hyundai Motorsport N, Mr. Kristo KRAAG, RedGrey as well as from Dr. André Filipe CONCHINHA, Portugal Event COVID-19 Manager and Dr. Guilherme SACRAMENTO, Deputy Portugal Event COVID-19 Manager as witnesses.

Hyundai Motorsport N are the stakeholder responsible for the cars entered as competition numbers 27 and 30 on Rally de Portugal. The cars are prepared and run on event by RedGrey.

It is the responsibility of the stakeholder to know that all personnel related to entries on World Rally Championship events are Fit to Attend, to monitor constantly that any of their Attendees remain or may be no longer Fit to Attend and can comply with the 2021 International Sporting Code, Appendix S.

The World Rally Championship and the FIA take the regulations of ISC Appendix S and the procedures to reduce the exposure to the pandemic extremely seriously.

Hyundai Motorsport N and their suppliers are reminded of the responsibilities placed upon them to ensure the safety of all personnel attending events.


