The Stewards, having received a report from the FIA Technical Delegate, and after hearing the competitor, have considered the following matter, determine the following:

Fact: No Accident Data Recorder (ADR) has been installed in the car.

Offence: Breach of the article 13.2 of 2022 FIA Cross-Country Rally Sporting Regulation.

Decision: To impose a fine of 1500 € to the above-mentioned competitor, which is suspended

during the FIA World Rally-Raid Championship 2022, subject to no other missing ADR

during this period.

Reason: The competitor declared that he was not aware of these new rules.

According the article 13.2 of 2022 FIA Cross-Country Rally Sporting Regulation, an Accident Data Recorder (ADR) complying with FIA Standard 8872-2018 "Accident Data Recorder" (listed in Technical List no. 88) must be installed in T1 cars manufactured from 2016 that participate in any Championship event. The ADR must be installed in accordance with the FIA ADR Installation Specification and manufacturer user's manual.

The Stewards understand that the ADR is useful to collect data in case of accident and it doesn't give an additional protection to the crews, and they do hence not consider the infringement of the above driver as a major infringement of the safety regulations which would, like in most other cases, give rise to a more severe sanction than the one imposed here.

The competitor declared that has the intention to participate in other events of the World Rally Raid Championship.

The Stewards finally conclude that there is a breach of the regulations and that a fine is necessary but sufficient for the reasons set out here.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3 f; Art. 12.3.1, Art. 12.4.1.c. and Art. 12.4.6.
