The Stewards, having received a report from the FIA Technical Delegate, summoned a competitor's representative, have considered the following matter and determine the following:

**Facts** The above addressed competitor used 28 tyres instead of the 26 tyres authorised for the rally, i.e. 2 tyres in excess of the permitted number

**Offence** Breach of Article 13.1.5 of the 2022 FIA WRC Sporting Regulations in conjunction with Article 7. 2 of the Rally Supplementary Regulations

**Decision** **No further action**


**Reason** The Stewards heard from the representative of Competitor No.85, Laura Borges, Sporting Co-ordinator, on 22 May 2022 at 17.15 hrs.

Ms Borges stated that, in preparation for Vodafone Rally de Portugal 2022, she downloaded the Supplementary Regulations from the event's website on 4 May 2022. This version of the Supplementary Regulations showed the maximum number of tyres permitted to be used as 34. This document was scrutinized by the Stewards and the relevant timestamps were noted.

The Stewards pointed out to Ms. Borges that the correct number of tyres in the FIA approved set of Supplementary Regulations (FIA approval given on 18 March 2022) for 'All other cars' is 26 - including Shakedown.

It is acknowledged that Competitor No. 85 did use two more tyres than permitted. However, they were following the supplementary regulations available until recently taken from the event official website. The Stewards therefore decide that the Competitor did not act in bad faith, and as such agree to take no further action against the competitor.


