The Stewards, having received a report from the Clerk of the Course, summoned and heard the above mentioned crew (Summons No. 6 Doc. No. 4.6), have considered the following matter, determine the following:

**Fact:** Failure by the crew to activate the OK display on the FIA Safety tracking device within one minute after stopping on special stage 4 on Friday, 14<sup>th</sup> May 2022 at 14:19 hrs. The OK button was pressed 1 minutes 50 seconds later.

**Offence:** Breach of Art. 53.3.3 of the 2022 FIA Regional Rally Sporting Regulations

**Decision: Reprimand**

**Reason:** The crew wanted to make representations and a hearing was held on Friday, 13<sup>th</sup> May 2022 at 21:00 hrs in the presence of both crew members. They explained that they had an accident in which the car rolled over. The first thing they did was to try to get out of the car, as the vehicle was in a dangerous place. At first they were confused but then they realised that they still had to press the OK button. They apologized for their lapse.

The Stewards concluded that the crew were non-priority drivers and that the delay of 50 seconds beyond the required limit was an infringement. Nevertheless, the stewards considers a reprimand to be sufficient in this case.

The decision is based on the FIA International Sporting Code Art. 11.9.1, art.11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f, and Art 12.4.1.b.
