The Stewards, having received a report with photos from the Marshal in charge and the Clerk of the Course, summoned and heard the above-mentioned crew (Summons No. 10 Doc. No. 4.10), have considered the following matter, determine the following:

**Fact:** Car No. 39 did not go around the elements of the chicane as shown in the Road Book at box 10 on SS 10. Car no. 39 hit one of the elements of the chicane.

**Offence:** Breach of Art. 19.2 of the 2022 FIA Regional Rally Sporting Regulations

**Decision:** **10 second time penalty added to the time of SS 10**

**Reason:** The Stewards examined photo evidence and heard the driver and co-driver of car no. 39. The co-driver accepted the report of the marshal even so he did not see the situation.

Box 10 on SS 10 in the Road Book clearly shows the itinerary to go around the elements which were put in place to create the chicane. The chicane constituted an essential safety element at the end of the race, aiming to slow the competitors and to ensure the safety of the participants.

The Stewards concluded the crew did not follow the mandatory itinerary and thus breaking the regulations.

The decision is based on the FIA International Sporting Code Art. 11.9.1, art.11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f, and Art 12.4.1.c.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
