**Please note and confirm the following regarding your event: -**

1. You should consult the relevant Highway Authority without delay to verify the status of the roads you wish to use, whether on public roads or private land. Before Authorisation can be granted this office will require on file a written declaration from you stating that, either:
  - (a) Having checked the definitive maps held by the Highway Authority we confirm that the route of the event does not include any footpaths, bridleways or restricted byways (now recorded in the same way as roads used as public paths where previously, on Authority records and OS mapping).

**OR**

- (b) The route of the event does include footpaths or bridleways or restricted byways (or any combination of these) and we confirm that permission has been sought and obtained for this use from the relevant Authorities in accordance with Section 33 of Road Traffic Act 1988.

NB This section of RTA'88 has been amended to include restricted byways.

2. Please remind competitors of Section 170 of the Road Traffic Act 1988 and Rule 286 of the Highway Code. Any injury incidents must be reported to the Police Authority. Details must also be included in the Stewards Report to this office.
3. You are required to forward a signed declaration that you have obtained permission for use of private property.
4. Please confirm compliance with standard condition 13: -
  - A: Where the route contains gates or cattle grids, the promoters must notify occupiers of the land.
  - B: Ensure that any gates are marshalled and the marshals open and close all gates.
  - C: Competitors shall not be required to leave their vehicles in order to open or close gates.
  - D: The course-closing car must check and record the closure of any gates.
5. Public Relations (PR) works along the route being a requirement under Standard Condition 8 of the controlling legislation and also a requirement of Motorsport UK General Regulations R2.1.4 & R3.1, you are aware of the additional thought and consideration on how you will be received by residents and the community who may still be feeling vulnerable at this time and may not take kindly to unexpected visitors. Therefore, whilst it's not currently permitted to make personal visits to householders to obtain signatures, PR works at this time is restricted to letter drop only. The letter must also inform residents if there is a control located within 500m and they are required to stop, or any other relevant event information.
6. Please note the 2022 authorisation vehicle fees (per vehicle) listed below: -
