Instructional designer and public health specialist. Capacity building officer in Immunization department at WHO for past 26 years. Her work involves design and delivery of training materials to support country immunization staff working at different levels and domains.



Director of Community Building & Digital Engagement at the Sabin Vaccine Institute where she oversees the Boost Community, an online global community of nearly 4,500 immunization professional members from 152 countries. She leads member engagement for this online platform, including executing multiple virtual trainings on 'softer' immunization skills as well as more technical topics.



Chief of Nutrition in UNICEF Guatemala, responsible for the areas of health and nutrition. Since 2009, Cecilia has worked for the World Food Programme and UNICEF in Peru, Uganda and Guatemala, as well as in regional offices in Latin America and Asia. In her current position, she has focused part of her work on immunization and cold chain strengthening.



Health Specialist and clinical epidemiologist. Leads the Health Program at UNICEF Guatemala, where immunization and maternal child health are a priority. She has been working in public health for 12 years, strengthening the Ministry of Health Cold Chain Equipment during the COVID-19 pandemic, reaching vulnerable populations in Guatemala.



Dr. Kapur is the Director of JSI India, an organization with a robust portfolio in immunization. He leads projects on capacity building, new vaccine introduction and provides expertise to support Government of India's immunization program. Dr. Kapur is a public health specialist by training and led USAID/India's health portfolio as technical lead.

Aim & Approach

2022 COVID-19 Recovery for Routine Immunization Programs Fellowship




- WHO & Sabin Vaccine Institute's Boost Community co-developed a fellowship in 2022 with the aim of building the capacity of national and sub-national immunization professionals to plan and implement activities for COVID-19 recovery and routine immunization strengthening
- Phase 1: Live engagement series (2 months) on topics related to COVID-19 immunization recovery
 - Strategic proposal or retrospective case study was developed during this phase
- Phase 2: Mentorship program (6 months) to help fellows revise and implement their strategic COVID-19 recovery plans or publish their case studies
 - Five mentors supported 30 Fellows (both Anglophone & Francophone)
 - Mentees met monthly with their mentor to get feedback, set goals, and track progress
 - Limited funding available, based on need.

How Governance Structures Facilitated the Development of an Online CCE Management Course



- Aim: To strengthen the capacity of health workers in the management of cold chain equipment (CCE) to improve immunization rates and increase vaccine coverage.


Aim & Approach

Rapid Immunization Skill Enhancement



India has 2,50,000 vaccinators, trained by instructor-led classroom trainings

- 1. Cascade based classroom training takes long time to saturate all HWs
- 2. Rapid changes in vaccination guidelines difficult to percolate
- 3. Frequent refresher and reinforcement required
- 4. Large variation in delivery & quality of training
- 5. Difficult logistics management especially in rural/remote areas
- 6. Tracking the training and measuring the outcomes complicated
