

VACCINATION CALENDAR

Instruction: Use this tool to determine: (a) whether or not the child is of the correct age for the vaccine(s) today; (b) the return date for the next dose of the multi-dose primary series for Penta, PCV, OPV, and Rota vaccines.

Before vaccinating the child, inter-personal communication (IPC) is vital:

- Always welcome mother/caregiver and ask about general well-being of the family. \checkmark
- Always ask if the child has any health problems now and also after previous vaccinations. \checkmark
- \checkmark Always counsel the mother on the importance of adhering to the vaccination schedule.

After vaccinating the child:

✓ Always tally on the tally form (T6) then document in the ZEPI register and child health card.

Always inform caregiver that the child will have pain on injection site and may develop fever or (and) rash. Explain that this is usually a normal reaction to vaccines but they should return to the HFs/HW, if worried about child's condition.

- ✓ Always give date of next visit reflected to your right in the same column as 'date given' and document it on the child's health card.
- Always quickly go through the card and educate the mother/caregiver on the importance of the Child Health Card and keeping it safe and that it will be a requirement for school entry.
- Always ask the mother/caregiver if she has any questions about any health issues pertaining to immunisation and also her own health, before she leaves.
- Always thank mother/caregiver for bringing the child for vaccination.

After vaccinating the child:

✓ Always tally on the tally form (T6) then document in the ZEPI register and child health card.

Always inform caregiver that the child will have pain on injection site and may develop fever or (and) rash. Explain that this is usually a normal reaction to vaccines but they should return to the HFs/HW, if worried about child's condition.

✓ Always give date of next visit reflected to your right in the same column as 'date given' and document it on the child's health card.

Always quickly go through the card and educate the mother/caregiver on the importance of the Child Health Card and keeping it safe and that it will be a requirement for school entry.

Always ask the mother/caregiver if she has any questions about any health issues pertaining to immunisation and also her own health, before she leaves.

Always thank mother/caregiver for bringing the child for vaccination.
