#### 3- RABAT 2019: AFRICAN GAMES

The 12th edition of the African games took place in Morocco from August 19 to 31, 2019.

One of the goals set by the African Union for these games is to promote African sport and foster cultural exchanges between African AU member countries. For this edition, the games were marked by the creation of a Coordination Commission (CCJA) made up of the African Union (AU), the Local Organizing Committee (COJAR), the Association of National Olympic Committees of 'Africa (ANOCA) and the Union of African Sports Confederation (UCSA).

It should be noted that this is the first time that ANOCA has been fully involved in the organization of these games by ensuring coordination with the various National Olympic Committees of Africa. Twenty-six (26) disciplines were included in the program of the games, of which seventeen (17) were qualifiers for the Olympic Games Tokyo 2020.

During the 3rd African Youth Games held in Algiers, we renewed, as during the last Senior African Championships hosted by Tunisia, to summon our own active and neutral Referees of good levels from the AJU Ranking List, Referees supported by their respective Federations for some and for other Referees by their personal means.

We send our deep gratitude to all these African Judo Federations and also to these designated Referees and volunteers to support their transport tickets.

**Standardization of Referee Licenses**: Regarding the license or grade, it is envisaged a standardization of licenses at the national, continental and international levels. This translates, in clear terms, to the elimination of B, C licenses.

The Federations should henceforth be free to act as they wish by choosing according to their own criteria which will not necessarily be competence criteria.

This situation deserves to be well considered more point in order to avoid seeing Referees of very low level officer in our big competitions when we see the arrival of the new generation of young high level athletes, well. trained and above all certified by the IJF ACADEMY.

# VERY SHORT-TERM RECOMMENDATIONS OF THE AJU REFEREE COMMISSION

As a first step in the short term, we can choose from the short list existing UJA 05 good active Referees of international level and 05 in the new generation of Referees (under 50 years old) who are arriving and imperatively to help them to climb the right steps such as:

- the IJF ACADEMY, which has become essential for any referee;
- IJF Referee seminars by local area in five (5) Zones to be defined (North-South-Center-East-West), in Africa to reach the most participants (this type of Referee seminar could well be keep up with Coaching);
- Support (transport tickets during major events not only on the African continent but on all international competitions in all continents (the IJF to support us in this Budget).

No complaints were registered with the coaches or trainers.

These referees guarantee neutrality, they will be able to harmonize their level and the one and only way for the Referee Commission of the AJU to present a reliable and efficient Ranking List.

In addition, we reminded the President of the relevance of our freedom to choose and to be able to have referees appointed by the Referee Commission and paid for by the AJU (transport tickets and accommodation) by the organizing country.

Since these referees must appear on the AJU Ranking List under the required conditions on which the Referee Commission will rule without delay, we can already retain the following points:

- To appear on the National Ranking List and to remain active with its National Federation;
- Be active at the continental level, in order to be able to evaluate its performance;
- Be between 30 and 50 years old;
- Speak in ordinary English;
- Undergo an IJF ACADEMY session.

#### MISSION REPORT - CONDUCT OF THE MISSION

#### 6.1- Recycling / clarification and competitions

The Senegalese Judo Federation (FSJDA) had applied for the organization of a seminar on the sidelines of the competitions. The agreement of Mr. President Habib SISSOKO and Vice-President Mohamed MERIDJA, Coordinator of Technical Departments, allowed the organization of a refresher and clarification session, followed by the summary by Mr. Khaled ANWAR, new Referee Director of AJU, on the last Mittersil 2019 Refereeing and Coaching Seminar held the day after the competitions.

The seminar and refresher session took place on November 15th. It was divided into 3 different sessions including a practical session on the tatami. The referees present were of different nationalities, including Cameroon, Nigeria, Niger, Senegal, Seychelles, Chad, Gabon, Burkina-Faso, Egypt, Libya and Tunisia. The number of participants was around 30. "



The clarification of the 2018-2020 IJF rules went as planned, before the draw at the Referees meeting, in accordance with the AJU's specifications for this Open.

#### 6.2- Standardization of Referee Licenses

# 6.5 DESIGNATED REFEREES - VOLUNTARY (Continental and international licenses)

### 6.5.1- Good practice

Good practice in these international OPEN competitions, especially qualifying for the Olympic Games, is to ensure good neutrality. In this regard, our appeal to volunteer Referees was not in vain: they displayed and applied perfect neutrality, thus attesting to their beneficial contribution, essential to the smooth running of the competitions.

As we know, Mr. President SISSOKO has given a favorable response to our request for neutral referees. The two Referees were thus made available to our Refereeing Commission during these OPEN Championships. Their participation was remarkably brilliant and they gave an excellent performance, beyond the expectations placed on them.

The following referees have been appointed and supported by the AJU: Ms. Yvette Sandrine / EVOUNDOU AKONO / Cameroon; Mr. Michel NGOME NDONG / Gabon.

The Federation of Judo and associated disciplines of Senegal, the organizing country, has made available to the AJU Referee Commission 07 referees of good level appearing in the top 10 of the national Ranking List.



**PERDIEM OF THE REFEREES**: The 24 Referees, all nationalities combined, received the sum of € 50 (fifty euros) from the President of FSJDA.

In accordance with our response to the Operating Budget, we want to have four neutral Referees in international competitions such as the African Open and Cadet / Junior Championships and the African Senior Championships.

We would also like to make available to the Referee Commission four (04) active referees at the rate of two (2) referees per Tatami. These referees guarantee neutrality. They will be able to harmonize their level, the one and only way for the AJU Referee Commission to present a reliable and efficient Ranking List. In addition, we have further explained to the President the relevance of the freedom to choose and to be able to have referees appointed by the Referee Commission and paid for by the AJU (transport tickets) and accommodation by the organizing country.

### 6.7- Being on the Ranking List

These referees must appear on the AJU Ranking List under the required conditions, on which moreover the Referee Commission will rule without delay. In this regard, we can already retain the following points:

- To appear on the National Ranking List and to remain active with its National Federation:
- Be active at the continental level, in order to be able to evaluate its performance;
- Be between 30 and 50 years old;
- Speak in ordinary English;
- Take an IJF Academy session.

#### 6.8- CARE SYSTEM

It should be noted, to deplore it, once again, the absence of a real Care System.

It therefore took all the ingenuity of Mr. ZIAD, IT Director, to find an alternative solution, by using the entry-level model of the Care system just sufficient for the National Championships, to view and analyze the fights. .It should be noted that we were

missing two (2) walkie-talkie radios for the supervisors of the AJU Refereeing Commission and connected to the Referees officiating on the two tatami mats.

Mr. ZIAD has once again confirmed what Mr. MERIDJA, Vice-President and Coordinator of Technical Departments of the AJU, had already communicated to us, namely that a Care System (professional range) has been ordered. It is in production and will be delivered shortly in order to arrive at a definitive solution.

### 7- AJU SEMINAR 2020: VISIOCONFERENCE (4 SESSIONS)

My intervention during the videoconference

ONLINE SEMINAR (WEBINAR) OF AJU TECHNICAL DIRECTORS



The webinar covered the work of the Sports Commission, the Refereeing Commission and the Education and Coaches Commission.

The August 08 session was the third session of 4 webinars, one per month, for the continent. The countries are divided into four groups according to the languages (two sessions in French and two in English).

### **Referees Online Seminar (Webinar)**

During this first meeting, MM. Ababacar NGOM and Khaled ANWAR, respectively Chief Referee Director and Director of the AJU Referee Commission, organized the following two parts: harmonization of the new version of the IJF continental and international licenses; IJF Referee Rules, based on the updated version of the IJF.

Harmonization of the new version of the continental and international licenses of the IJF.

Regarding the harmonization of the new version of the continental and international licenses of the IJF, it was a question of explaining the new rules for obtaining the continental and international license. It was also a question of encouraging the Federations to register the Referees in the new database of Judo (JUDO DATABASE).

An early announcement was made about the location and time of the next continental exam. All conditions for continental and international exams were clearly illustrated.

Detailed explanation of the IJF Referee Rules. Based on the updated version of the January 2020 IJF at the Doha seminar. Regarding the IJF Referee Rules, we explained them, in detail, based on the updated version of the IJF from January 2020, at the Doha seminar.



This session was based on selective slides. The selection included cases updated according to the Doha seminar. It was based on the new slides published and approved by the IJF.

Conclusion: In closing, I reiterate my sincere thanks to Mr. MERIDJA for his constant support, whenever our Refereeing Commission needed his always timely intervention. Finally, we continue to work under the technical instructions of the IJF, to to succeed in this important mission, we would like multifaceted support from our prestigious IJF Refereeing Commission.

The Cameroonian Judo Federation hosted and organized the seminar on the sidelines of the competitions. An organization of a refresher and clarification session prepared by Mr. Khaled ANWAR, Director of Referees of the AJU, on the latest updates of Referees and coaches 2020, a systematic update of the rules and a harmonization of Referees. This harmonization took place on the morning of the day of the draw in WHITE JUDOJI.

The seminar was chaired by Mr. Ababacar NGOM, Head Referee Director of AJU,

Mr. Khaled ANWAR, Referee Director - AJU.

The first session was about the explanation of the new IJF 2020 rules, the second session was a refresher on video cases and practical training on Tatami.

Thirty-two people were present: 2 international referees, 8 continental, 16 national and 6 coaches.







### The championship (7-8 November)

Appointment and Availability of Referees: All referees participated voluntarily. The number of referee was 10 (1 was absent after the first day). It has been difficult for many Volunteer Referees according to the current flight situation due to the pandemic. The championship therefore depended on the Cameroonian Referees.


