- 2. Arborist's Report: McMullin explains that there is finally some good news to report. There may be a treatment coming out soon for Beech Leaf disease. He noted that we should start seeing the decline in Oak Trees with Bacterial Leaf Scorch which can slowly kill a tree over 8-10 years. Chemical companies and Arborist are closely working together in order to come up with a treatment.
