Meeting Discussions:

1. Review and Approval of Meeting Minutes:

• The February 21, 2018 Minutes were approved by a voice vote of all STC members present.

2. Subdivision Plans and Land Development Waiver Applications: None

3. Special Presentation by PECO: PECO made a presentation to the Shade Tree Commission on their ongoing tree work, so their electric distribution lines in the Borough can continue to operate with as few interruptions from trees as possible. PECO contracts Davey Resource Group to determine what needs to be done and they contract Asplundh to do the tree work.

PECO has worked closely with Dave on these activities. PECO provided a list of diseased, dying or dead Ash trees that are of the highest risk to PECO electric facilities and need to be removed. These trees will be removed beginning in May.

Also, PECO is pruning tree branches within five or six feet of the primary electric distribution lines at the top of their electric poles.

PECO said there is list of the "Right Trees in the Right Place" on their web site to help people chose trees to plant near electric lines.

- (7) 73 E. State Street, Jon Paton, Applicant. One Douglas Cedar. This tree was removed as emergency storm damage. *Approved*.
- (8) 117 E. Oakland Avenue, Lynn Goldman, Applicant. One Ash. *Approved* by a voice vote, with a recommendation to replace the tree.

5. Old Business and Reports:

- (1) Lantern Hill: A new date will be selected for the Shade Tree Commission site visit to look at the trees that may be removed.
- (2) Street Tree Planting: Dave reported that he has created a spread sheet with relevant information for street tree planting.
- (3) Arborist Report: Bob will present a report next month.
- (4) Arbor Day: To celebrate Arbor Day, the Borough will give away trees for planting by residents. Dave will send out an email to the Shade Tree Commission, Borough Council, and the Borough EAC asking for volunteers to work at the tree handout table at the Farmer's Market on Saturday April 29th.

6. New Business

- (1) Oak Tree at 168 E. Oakland Avenue: Denny Brown came the meeting to inform the Shade Tree Commission about activity related to trying to save the Oak Tree.
- (2) Borough Council requested information from the Shade Tree Commission on how to best get rid of vines covering shade trees. Bob will get some written information that can be used.
