2. Arborist and Borough Tree Report:

- **a.** Bob and Dave reported; Watering and other tree and plant care is continuing. During the hot dry weather this summer, tree Gator watering bags were used on the trees in Broad Street Commons Park. Chris cautioned that during hot weather the temperature between a tree and a Gator bag which surrounds the tree trunk can be very high and may be harmful to the tree. Dave will take the caution under advisement. Work is continuing on the berms in the park and the butterfly garden.
- b. Dave reported: The Borough has been doing maintenance work on the trees in several of the Borough parking lots and other parks. In the Plaza East Parking Lot they removed a Zelkova and one other tree. Tree work is also being done in the Kenny's Parking Lot.
