In consideration of the provision of water service by the BOROUGH OF DOYLESTOWN and sewer service by the BUCKS COUNTY WATER/SEWER AUTHORITY to the premises described in paragraph 1 above, the undersigned, intending to be legally bound hereby, agree to be individually, jointly and severally responsible for the payment of all charges, fees, rents or other costs charged or imposed in conjunction with the provision of such water and sewer service pursuant to the provisions of Chapter 18 and Chapter 19 of the Code of Ordinances of the Borough of Doylestown, the provisions of the Sewage System Purchase Agreement dated November 22, 1994 and The Billing Services Agreement dated December 21, 1994 between the BOROUGH OF DOYLESTOWN and BUCKS COUNTY WATER/SEWER AUTHORITY as well as any resolutions of the Borough Council and/or the Bucks County Water/Sewer Authority relating thereto.

The undersigned further agree that this water and sewer account shall be place in the name of the party designated in the above "Account Name" caption and that all bills and notices relating to such water and sewer service account shall be sent to the mailing address of such party as set forth above in paragraph 2 or 3, as the case may be.

9. Nothing contained herein shall be construed to relieve the owner of the real property described in Paragraph 1 above from liability for the payment of such water and sewer service as may be otherwise imposed by any applicable statute, ordinance, rule, regulation or resolution.
