Course Objectives

The history of India's Partition forms an inalienable part of the subcontinent's history. A thorough and objective study of the event, the processes and the aftermath shall equip students with a greater understanding of a significant part of India's modern and contemporary history. The students at the level of the Masters need to undertake an in-depth study of how the country was partitioned with the complex interplay of parties and forces, including the Congress, the Muslim League, the Colonial State, and others. The millions of people who got displaced as a result and crossed boundaries led to a massive transformation in culture, economy, demography and urban settlement patterns. These continue to affect and challenge modern-day realities. The representation of Partition in history books is paralleled by some serious engagement with the process and its impact in literary genres and visual media. Recent thrust on studies on Partition has made this course all the more imperative. Students would find space for serious engagement with the topics and various nuances through assignments, class tests, presentations, visits to archives and museums, watching films, and engaging in discussions on important literary texts on and around the theme of Partition.

Learning Outcomes

After completing this course, students shall be able to—

- (i) Appreciate better the complex process of politics at play in leading India to Partition.
- (ii) Connect better the various processes in India's late colonial past.
- (iii) Understand better the objectives, slogans, electoral politics, individual aspirations, colonial machinations in modern Indian history.
- (iv) Students would be able to study the history of the growth of Indian nationalism, along with currents of communal divide and politics around identities and communities.
- (v) They would be able to visualize the process of Partition and its impact, as well the changes in geographical boundaries caused by Partition.

Course Content

Unit-I: (Week 1-3): Strategies of Mapping and Enumeration, Legislative Expansion, Growth of Communalism, Khilafat and Non-Co-operation, Shuddhi and Tabligh, Nehru Report, Round Table Conferences Minority Committee, Historiography on Partition,

Unit-II: (Week 4-5): From Communal Award to Simla Conference, Elections and formation of governments under Provincial Autonomy 1937, Second World War and Resignation of Ministries; Muslim League's Two-Nation theory, Gandhi-Jinnah Talks (1944).

Unit-III: (Week 6-8): High Politics of India's Partition (1945-47), Cabinet Mission Plan, Interim Government, Setting up of Constituent Assembly, Direct Action.

Unit-IV: (Week 9-11): Partition turns into reality, Regional variations, Transfer of Power and Integration of States.

Unit-V: (Week 12-13): Migration, Displacement, Rehabilitation, Impact on Women.

Unit-VI: (Week 14-15): Visual and Literary Landscapes, Representation of Partition and its related events in literature and films.
