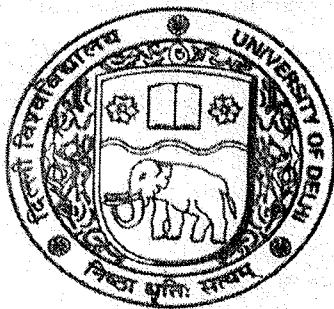

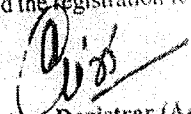
ADMISSION NOTIFICATION

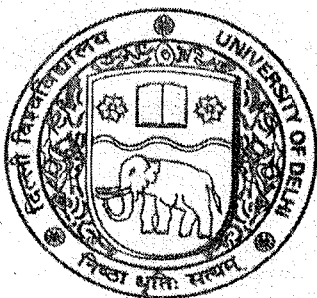
1. It is notified for all concerned that the **Admission to UG (BHMS) Courses under 85% Delhi Quota** for the session 2026-27 in Faculty of Ayurveda & Unani Medicine and Homocopathy Medicines, University of Delhi, will be undertaken on the basis of merit of NEET-UG-2026-27 conducted by NTA.
2. Only, eligible candidates are required to register on online portal link <https://faumadmission.uod.ac.in/index.php> at Faculty website <https://fmssc.du.ac.in/> to participate in the Counselling for admission to UG (BHMS) Courses.

Instruction for the candidates for admission in University of Delhi in Undergraduate (BAMS*/BUMS*/BHMS) Course under 15% All India Quota as well as 85% Delhi Quota after allotment of seat in the Academic Year 2026-27.

A. 1st Round

1. The candidates who are allotted seat in Institute affiliated to University of Delhi under 15% All India Quota as well as 85% Delhi Quota are required to register themselves online for admission to BAMS*/BUMS*/BHMS Course on the Faculty website <https://fmssc.du.ac.in/> at following links as the case may be:

2. Consequent upon submission of prescribed fees, an online fees receipt shall be generated for the students.
3. The candidates shall report to the concerned college/institutions alongwith printout of filled in online application form, fee receipt and the following original certificates for verification and for completing the admission:

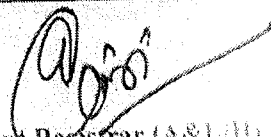
- (i) Passport size photograph of the applicant (120x130) (only jpg & size upto 10- 50 KB)
- (ii) Copy of NEET-UG-2026 Admit Card (only PDF & size upto 100 -500 KB).
- (iii) Copy of NEET-UG-2026 Score Card (only PDF & size upto 100-500 KB).
- (iv) Copy of Aadhar Card (only PDF & size upto 100-500 KB).
- (v) Scanned signature of the applicant (200x50) (only jpg & size upto 10- 50 KB)
- (vi) Copy of High School/Matriculation/Secondary examination Certificate for admission to BAMS/BUMS/BHMS program (only PDF & Size 100- 500 KB).
- (vii) Copy of 10+2 Marksheet/certificate (only PDF & size upto 100- 500 KB).
- (viii) Certificate from the Principal of the School on prescribed proforma available in UG BOI 2026 at faculty website: <https://fmssc.du.ac.in/> stating that (i) the school is situated within National Capital Territory of Delhi, (ii) the school is recognized by the CBSE/Council for the Indian School Certificate/ Jamia Millia Islamia, (iii) the school is conducting regular classes, (iv) the applicant has attended regular classes in the school for class 11th & 12th. (only PDF & size upto 100- 500 KB) (Important Certificate).
- (ix) Copy of Character Certificate in proforma as prescribed by CBSE, issued by the Principal of the school last attended or any Gazetted Officer (Only PDF & size upto 100-500 KB).
- (x) Copy of Scheduled Caste/ Scheduled Tribe certificate, if applicable. (Only PDF & size 100-500 KB).

- (xi) Copy of OBC Non-creamy layer certificate (in the name of the candidate) issued after 01/04/2026 by the competent authority and OBC caste certificate as per the Central list for OBC's (only PDF & size upto 100-500 KB).
- (xii) Copy of Person with Disability (PwBD) certificates, if applicable (only PDF & size upto 100- 500 KB).
- (xiii) Entitlement Certificate for C.W. category, if applicable. (Only PDF & size upto 100-500 KB).
- (xiv) Copy of EWS Certificate (in the name of the candidate) issued after 01/04/2026 by the competent authority, if applicable. (only PDF & size upto 100-500KB).
- (xv) Copy of Overseas citizens of India (OCI) card, if applicable.
- (xvi) Medical fitness certificate as per Annexures.
- (xvii) Surety Bond as per Annexures.

Note: The candidates are required to bring Printout of Registration Form, Provisional Allotment letter alongwith Original Certificates (02 sets) of self-attested photocopies at the time of admission at the respective allotted College.

- (a) Please note that the candidature is subject to the candidate's fulfilling the minimum eligibility requirements prescribed for applying to the concerned Programme of study.
- (b) After verification of the documents and approval of the concerned college the candidate can download the Provisional Admission Letter from the Delhi University-UG Portal.
- (c) The candidate will be required to deposit the admission fee within the stipulated time to finalize the admission process.
- (d) * The A&U Tibbia College has not provided any permission letter from the NCISM to the University of Delhi for UG(BAMS/BUMS) Program in the academic year 2026-27 so far. Hence, the total seats for the said program are 'NIL' till any update from the concerned college. The revised seat matrix shall be uploaded on the Faculty website after getting permission from the NCISM in due program of time.

In case a candidate does not meet the minimum eligibility, criteria prescribed for applying to the concerned Programme, it is done at the candidate's own risk and cost. If at any stage, it is found that the minimum eligibility requirements are not fulfilled, the admission if granted, shall be cancelled ipso-facto and the fees paid, if any, shall not be refunded in any case.
