

Privacy Notice for Enhanced Partnership Consultation

This privacy notice was completed in August 2022 and will be regularly reviewed. When we use your personal data, CYC complies with data protection legislation and is the registered 'Controller'. Our data protection notification is registered with the Information Commissioner's Office (ICO) – reference **Z5809563**.

Why is information being collected?

It is a requirement of the Bus Services Act 2017 that a public consultation takes place in advance of forming a statutory Enhanced Partnership between the council and local bus operators. The Department for Transport requires the council to form an Enhanced Partnership as a condition of its indicative £17.3m Bus Service Improvement Plan funding for the city.

What information will be collected?

We are collecting your approximate age and partial postcode, along with your opinions and feedback in response to the council's draft Enhanced Partnership Plan and Scheme. If you are responding on behalf of an organisation, we will collect the name of your organisation.

Participation is voluntary and you can choose to not answer any of the questions.

What will we do with the information?

We are using the information you give us with your consent. You can withdraw your consent at any time by contacting buses@york.gov.uk.

The information we collect will be used to evaluate resident and stakeholder opinions of the draft Enhanced Partnership Plan and Scheme. Any analysis shared outside of the authorised council staff will be anonymised and cannot be linked back to you, your family, or individuals. Reports containing anonymous information may also be shared with the general public and other organisations.

We will protect it and make sure nobody has access to it who shouldn't and we will not keep it for longer than is necessary.

If you have completed a paper survey, once you complete and return it to us, we will transfer the information you have given us onto the council's secure network and then destroy confidentially the paper copy.

We will not use the information for any other purpose than set out in this privacy notice and will not disclose to a third party i.e. other companies or individuals, unless we are required to do so by law for the prevention of crime and detection of fraud,

or, in some circumstances, when we feel that you or others are at risk.

Storage of information

We will keep the information you give us in CYC's secure network drive and make sure it can only be accessed by authorised staff.

How long will we keep the information?

We will keep the information you give us for up to three years and then will securely and confidentially destroy it.

Where required or appropriate, at the end of the retention period we will pass onto the City Archives any relevant information.

Further processing

If we wish to use your personal information for a new purpose, not covered by this Privacy Notice, we will provide you with a new notice explaining the purpose prior to commencing the processing and the processing conditions. Where and whenever necessary, we will seek your consent prior to the new processing.
