Moreover I oblige myself:

- Not to use any document copying equipment;
- To access only the areas for which I have appropriate permission for;

Information on the processing of personal data

The data obtained will be processed by SEAT for the purpose set out in the previous paragraphs. No automated decisions will be made based on your personal data. The legal basis of the treatment is, consequently, the consent given by you and that you can withdraw at any time as indicated below.

SEAT will keep your personal data as long as you do not withdraw the consent given or until the purpose for which they have been collected has been fulfilled. Once any of these assumptions have occurred, SEAT will only keep your personal data for the time necessary to comply with the legal obligations that correspond in each case. Once the corresponding legal obligations have been fulfilled, SEAT will delete your personal data.

Your data will be processed only by: (i) those third parties to whom SEAT is legally obliged to communicate them; (ii) those to whom SEAT has entrusted the provision of a service related to the management or execution of the purposes of the treatment and that implies access to your personal data; (iii) other companies of the business group to the extent necessary to fulfill the purpose of the treatment.

You may exercise before SEAT at any time, in the terms established by current legislation, your rights of access, rectification or deletion of data, as well as request that the processing of your respective personal data be limited, oppose it, request the portability of your data or revoke the consent given by contacting the email customer care@seat.es. Finally, you can file a claim with the Spanish Data Protection Agency if you consider that SEAT has not processed your personal data in accordance with the applicable regulations.
