

TERMS & CONDITIONS

HOSTED BUYER PROGRAMME

WHAT IS INCLUDED IN THE SPORTS & EVENTS HOSTED BUYER PROGRAMME?

- A minimum of 24 pre-arranged one-to-one meetings with selected top suppliers
- 4 days / 3 nights accommodation at an official partner hotel in Antalya
- Round-trip flights arranged and covered by the organiser, subject to a refundable €200 deposit and compliance with Hosted Buyer obligations
- Local transfers in Antalya, including airport transfers (arrival and departure)
- Welcome cocktail and hosted meals at selected venues
- Unique experiences and site visits curated by local experts
- Access to contact details and company profiles of all participating suppliers

WHAT IS NOT INCLUDED:

- Personal room expenses such as minibar, laundry, out-of-programme meals, transport, etc. incurred during the stay
- Additional nights outside the official programme dates (May 31 – June 3, 2026)
- Travel to and from the buyer's local airport
- Transport costs incurred if official transfers are missed
- Any additional charges resulting from travel changes requested by the buyer

FLIGHT BOOKING & REFUNDABLE DEPOSIT

To secure flight bookings as part of the Hosted Buyer Programme, a refundable deposit of €200 is required and must be paid via the official Flight Booking Form.

- This deposit acts as a commitment guarantee and enables the organiser to proceed with flight bookings on behalf of the Hosted Buyer.
- Flights are arranged in coordination with official partners and, where applicable, the Turkish Government.

Refund policy

- The €200 refundable deposit will be fully refunded within 7-10 working days after the event, provided that the Hosted Buyer:
 - Attends Sports & Events Türkiye in person
 - Completes a minimum of 24 pre-arranged one-to-one meetings
 - Participates in the full official programme, including networking and social activities
- In the event of non-attendance, late cancellation, or failure to comply with Hosted Buyer obligations, the deposit will be retained by the organiser.

Additional conditions

- Accommodation, meals and activities are included only during the official event dates (May 31 – June 3, 2026).
- Any costs resulting from early arrival or late departure (additional accommodation, meals, transfers, etc.) must be covered by the buyer, even if flights are arranged outside the official dates.
- The organiser is not responsible for additional costs arising from incorrect or incomplete personal or travel information provided by the buyer.

PARTICIPATION CONDITIONS

Your Data & Privacy

By attending the event, you agree to allow MeetingPacks SL – Sports & Events to store and process your professional contact data in accordance with applicable European data protection regulations.

- Your contact information will be shared with participating suppliers for networking and business purposes.
- The organisers reserve the right to verify the information provided in your application to ensure a high professional standard. This may include reference checks.
- The organiser may take photographs and/or video recordings during the Event and use them for Event promotion, unless the Buyer submits a written opt-out request prior to the Event. Reasonable efforts will be made to respect such requests; however, complete exclusion from group footage cannot be guaranteed.
- If you have any disability or medical condition requiring special arrangements, please inform the organisers during registration.

Appointments & Attendance

- Hosted Buyers are required to attend a minimum of 24 pre-arranged one-to-one meetings, each lasting approximately 15 minutes.
- Meeting agendas will be scheduled based on the interests indicated during the application process.
- Attendance at all official networking activities, including lunches, dinners and social events, is mandatory.

TRAVEL REGULATIONS

It is the buyer's responsibility to ensure compliance with travel requirements, including valid passports, visas (if applicable), and the ability to travel on the confirmed dates.

CANCELLATION & PENALTIES

Credit card details will be required as a guarantee to cover any additional costs, penalties, or obligations not fulfilled by the buyer.

Participation as a Hosted Buyer is non-transferable. Should a colleague wish to attend in your place, a new application must be submitted and will be subject to approval.

In the event that the organiser is required to cancel the event, no claims for consequential losses or costs will be accepted.

Buyers are liable for any damage caused at event venues and must comply with all venue rules and conduct policies. The organisers accept no liability for loss or damage to personal property brought to the event.

Failure to attend the event or to comply with Hosted Buyer obligations may result in the forfeiture of the refundable flight deposit

FORCE MAJEURE

MeetingPacks SL – Sports & Events shall not be held liable for any failure or delay caused by force majeure events. In such cases, the organiser reserves the right to cancel, postpone, reschedule, or modify the event or venue.
