

TERMS & CONDITIONS INTERNATIONAL HOSTED BUYER PROGRAMME

WHAT IS INCLUDED IN THE MIS INTERNATIONAL HOSTED BUYER PROGRAMME?

- 26 pre-arranged 1-2-1 appointments with top suppliers of your choice (destinations, hotels, venues and DMCs in Spain and Portugal).
- 2 Nights' accommodation at the host hotel.
- Return flights (cost coverage up to €350) and airport transfers upon arrival and departure from the host destination.
- Gastronomical experiences that include welcome reception, lunches and meals organised in unique venues
- Group activities designed by local experts to discover the host destination.
- Contact details and descriptions of all participating suppliers.

WHAT IS NOT INCLUDED:

- Hotel extra expenses such as mini bar, out of programme meals, laundry services, taxis or other non-official transportation, etc. incurred during the stay.
- Extra nights stay.
- Travel to and from your local airport is not included and will not be reimbursed. Transport charges incurred if you miss the official buses.
- Any extra charges due to travel changes decided by the buyer will be charged back to the buyer.

PARTICIPATION CONDITIONS:

Your data

By attending the event, you agree to allow Grupo eventoplus to electronically save your business data, contact details and information within our database which is duly registered and kept under European regulation. We will share your contact information with the suppliers attending the event.

The organisers will validate the information in your application as well as conduct check references and other information supplied by you.

If you have a disability or medical condition that requires special arrangements to be made, please notify us of your requirements when registering.

Appointments & Activities

Attendance to a minimum of 26 pre-arranged appointments with a selection of top suppliers from Spain and Portugal is compulsory. Each appointment will last 15 minutes. It is your responsibility to organise your meeting agenda with the suppliers that you are interested in.

Attendance is compulsory to all official social events (dinners, lunches, etc.) programmed during the event.

Travel regulations

It is your responsibility to ensure that you can travel on the dates you have selected and that you have the necessary and valid travel documentation (passport, visas if applicable).

Cancellation & penalties

- If the applicant to the International Buyer Programme has purchased the flight tickets and cancel the participation in the event, Grupo eventoplus will not reimburse this cost as well as other costs that may be incurred. Should Grupo eventoplus cancel the event, flight tickets will be reimbursed if it has been purchased. Other than that, there can be no claim for any consequential damage or cost incurred as a result.
- If Grupo eventoplus has purchased the flight tickets and the applicant cancel the participation to the event, all costs incurred due to the cancellation will be charged back to the applicant, such as flight costs as well as a €100 management charge to their credit card. Grupo eventoplus will require details of the credit card for use in case of any extra charges or cancellation charges incurred and any obligations not fulfilled by the buyer.

Participation as International Buyer is not transferable. If you are unable to attend the event and would like your colleague to attend instead, he/she will be required to fill in the application form and Grupo eventoplus reserves the right to accept/decline the application.

We accept no liability for damage to, or loss of any of your property that you bring to the event.
