1. Who We Are

This Privacy Policy explains how Fabra Davies Network S.L. ("Fabra Davies", "we", "us" or "our"), organiser of MoodleMoot Europe 2026, collects, uses and protects your personal data.

2. Personal Data We Collect

We may collect:

- Name and business contact details.
- Organisation and job title.
- Billing information where applicable.
- Dietary requirements and accessibility information voluntarily provided.
- Marketing preferences.
- Sponsor consent preferences.

3. Purposes of Processing

We process personal data to:

- administer the Event;
- provide event-related services;
- process payments and invoices;
- communicate important event information;
- comply with legal obligations;
- improve future editions of the Event; and
- send marketing communications where you have provided your consent or another lawful basis applies.

4. Legal Basis

Depending on the processing activity, we rely on one or more of the following legal bases under Article 6 GDPR:

- Performance of a contract.
- Compliance with legal obligations.

- Legitimate interests.
- Consent, where required by law.

5. Marketing Communications

Where you have provided your consent, or where another lawful basis applies under applicable data protection legislation, Fabra Davies Network S.L. may send you information relating to conferences, educational programmes, technology initiatives and other professional activities organised or promoted by Fabra Davies Network S.L.

Every communication includes a simple mechanism allowing you to unsubscribe or object to future communications at any time.

6. Sponsor Communications and Data Sharing

During registration you may choose whether your professional contact details may be shared with selected Event Sponsors.

Where you have chosen to do so during registration, Fabra Davies Network S.L. may share your professional contact details with Platinum Sponsors, Gold Sponsors and designated Strategic Partners participating in the Event.

Sponsors receiving your information act as independent data controllers and process personal data in accordance with their own privacy policies.

7. Disclosure of Personal Data

Personal data may be disclosed to:

- service providers supporting the Event;
- Moodle Pty Ltd, where required under the Official MoodleMoot Organisers Agreement;
- public authorities where required by law; and
- Event Sponsors, where you have chosen to share your information during registration.

8. Our Commitment to Data Protection

We process personal data collected by Fabra Davies Network S.L. in accordance with the General Data Protection Regulation (EU) 2016/679 ("GDPR") and other applicable data protection legislation.

Personal data are processed only where an appropriate legal basis exists and solely for the purposes described in this Privacy Policy.

Depending on the nature of the processing, the applicable legal basis may include the performance of a contract, compliance with legal obligations, our legitimate interests, or your consent where required by law.

Fabra Davies Network S.L. is committed to processing personal data lawfully, fairly and transparently, while respecting the rights and freedoms of individuals.

9. International Transfers

Where personal data is transferred outside the European Economic Area, appropriate safeguards will be implemented in accordance with applicable data protection legislation.

10. Data Security

We implement appropriate technical and organisational measures designed to protect personal data against accidental or unlawful destruction, loss, alteration, unauthorised disclosure or access.

11. Data Retention

Personal data are retained only for as long as necessary for the purposes described in this Policy or to comply with applicable legal obligations.

12. Your Rights

You may request access, rectification, erasure, restriction, portability, object to processing or withdraw your consent by contacting hello@fabradavies.com. You also have the right to lodge a complaint with the competent data protection authority.

13. Automated Decision Making

We do not make decisions based solely on automated processing, including profiling, that produce legal or similarly significant effects.
