HOSTED BUYER PROGRAMME

WHAT IS INCLUDED IN THE SPORTS & EVENTS

HOSTED BUYER PROGRAMME?

- A minimum of 24 pre-arranged 1-to-1 meetings with selected suppliers
- 2 nights' accommodation at one of our partner hotels in Valencia
- Return travel costs (flight or train) covered up to €350, plus local transfers in Valencia
- Welcome cocktail and meals at selected venues throughout the programme
- Sports, cultural and networking activities and experiences organised as part of the official programme
- Contact details and company information of participating suppliers

WHAT IS NOT INCLUDED:

- Personal expenses incurred during your stay, such as minibar charges, meals outside the official programme, laundry services, additional transport, etc.
- Additional nights or accommodation outside the official programme dates
- Travel to and from your local airport or train station. These costs are not included and will not be reimbursed.
- Any transport costs incurred as a result of missing the official transfers
- Any additional costs resulting from travel changes requested by the buyer

PARTICIPATION CONDITIONS

Your data

By attending the event, you agree to allow Sports & Events Europe – MeetingPacks SL to electronically store your business data, contact details and other information provided during the application and registration process in accordance with applicable European data protection regulations.

Your professional contact information may be shared with suppliers participating in the event for the purpose of facilitating meetings and business opportunities.

The organisers may review and verify the information provided in your application, including references and other relevant information, as part of the Hosted Buyer selection process.

Meetings & Activities

Attendance at a minimum of 24 pre-arranged 1-to-1 meetings with selected suppliers is compulsory. Each meeting will last approximately 15 minutes. Your meeting agenda will be organised based on the business interests and preferences indicated in your application.

Attendance at all official activities included in the Hosted Buyer Programme, including lunches, dinners, networking activities and other scheduled events, is compulsory.

TRAVEL REGULATIONS

Eligible flight or train costs of up to €350 will be reimbursed via bank transfer within 7–10 working days after the event, subject to submission of the required travel and reimbursement documentation.

Sports & Events Europe may require credit card details to cover applicable cancellation charges, additional expenses or other charges incurred by the buyer in accordance with these Terms & Conditions.

Should Sports & Events Europe have to cancel the event, there can be no claim for any consequential damage or additional costs incurred as a result.

Participation in the Hosted Buyer Programme is not transferable. If you are unable to attend and would like a colleague to participate instead, they will be required to submit a new application. Sports & Events Europe reserves the right to accept or decline the replacement application.

You are liable for any loss or damage you may cause to an event venue and agree to comply with all rules, procedures and policies, including standards of behaviour and conduct, applicable at any venue used during the programme.
