## N. OWNER AND OWNER GUEST LOT RESERVATION PROCEDURE

- 1. The lot owner must notify the resort manager by email or phone prior to utilizing their lot for personal use. Notification for use on an immediately upcoming Saturday, Sunday, or Monday must be made no later than 3 PM on the preceding Friday. If notification is not made by 3 PM, the lot owner must inquire with the rental office by phone to determine if their lot is currently rented and to request it be held for their use if not. Notification should also be given to the property manager by email or phone for tracking purposes.
- A. Personal use is defined as use by the lot owner or a non-paying guest of the lot owner.
- B. When making the reservation, the lot owner must provide the start date of the reservation, the guest name(s) (if applicable), and optionally the end date of the reservation if known.
- 2. Upon receipt of a reservation request, the resort manager will confirm the lot owner is authorized to reserve the lot in question and will forward the reservation details to the rental office so that the lot can be removed from the rental pool.
