To Whom it may concern:

The Hidden Oaks Homeowners Association is seeking proposals from qualified and experienced lawn maintenance service providers to fulfill our lawn maintenance needs. We invite your company to submit a proposal for the provision of lawn maintenance services as outlined below.

1. Project Overview:

- 1.1 The scope of work includes regular lawn maintenance services for the common areas of Hidden Oaks Homeowners Association.
- 1.2 The common areas comprise of the following within the community:
  - Two main entrances (East and West)
  - Thirty townhomes
  - Two playgrounds (Hidden Oaks @ Addison and Libby Lane)
  - Four open lots (Lawton @ Dunvegan, Lawton @ Churchwood, McCloud and Easement lot into Turtle Creek)
  - One right of way (Lawton cul-de-sac)
  - Median in cul-de-sac on Dunvegan Dr.
  - Median on Hidden Oaks Dr. around Oak Tree
- 1.3 The contract duration will be for April through November for a period of eight months with the option for renewal upon mutual agreement.

2. Services Required:

- 2.1 The selected lawn maintenance service provider shall be responsible for the following services:
  - a. Lawn mowing, trimming, and edging on a regular schedule.
  - b. Weed control and removal from landscaped areas and pathways.
  - c. Leaf and debris cleanup and removal from common areas.
  - d. Fertilization and weed treatment as necessary.
  - e. Shrub trimming twice per year.
  - f. Other related services as required for maintaining the aesthetic appeal and health of the common areas.

3. Proposal Submission:

- 3.1 Interested lawn maintenance service providers are requested to submit a proposal that includes the following information:
  - a. **Company Information:** Provide proof of insurance, bond and licensing

- b. **Scope of Services:** Clearly outline the services your company will provide as per the requirements mentioned in Section 2.
  - c. **Schedule:** Provide a proposed schedule for lawn maintenance activities, including frequency and estimated timeframes for each service.
  - d. **Pricing:** Present a detailed pricing structure for your services, including any additional costs or options.
  - e. **References:** Include references from previous clients who can verify the quality and reliability of your services.
- 4. Proposal Evaluation:
  - 4.1 The evaluation of proposals will be based on the following criteria:
    - a. Experience and Qualifications
    - b. Demonstrated Capability to Meet Requirements
    - c. Quality and Methodology of Services
    - d. Pricing and Cost-effectiveness
    - e. References and Client Feedback
- 5. Proposal Submission Deadline:
  - 5.1 Proposals must be received no later than March 12, 2026. Late submissions may not be considered for evaluation.
