- The customer must have a valid learning application.
- To request a remote interpretation of the Knowledge test, the customer must book the service 5 days before the scheduled Knowledge test date.
- Knowledge test: the customer must complete all the theory training requirements.
- Yard test: the customer must complete the training requirements and pass the Knowledge test and the Evaluation test of the driving institutes.
- Road test: the customer must complete the training requirements and pass the Knowledge and Yard tests and settle all the fees.
- If the customer doesn't show up for the test, he must book a new test appointment and pay the required fees.
- If the customer wishes to book an appointment during official holidays, he must pay additional fees to the driving institute.
- After passing each test, the customer receives an email and an SMS with a link to book the appointment for the next test.
- After each failed road test, the customer must take 4 classes before the next test.

Apply for Appealing a Road Test Results

- **Eligibility:**

Trainees who failed the Road test for the following categories: light vehicle, heavy vehicle, heavy bus, and light bus are eligible to apply for this service within 14 days from the road test results.

Emirates ID number.

Apply for Changing a Light Vehicle Driving License from Automatic to Manual

- **Eligibility:**

Customers with a valid driving license issued in Dubai are eligible to benefit from this service.

- **Required documents:**

Original valid Emirates ID.

- **Terms and conditions:**

- The customer must undergo an eye test before applying for the service.

- The customer can change the appointment of the test 24 hours prior to the test date in case he wanted to postpone it, and at any time if he wants to prepone the test date provided that there's an available appointment and that he settles the required fees (320 AED to prepone an already scheduled test appointment).

- The customer does not need a learning application.

Apply for a New Driving License

- **Eligibility:**

Individual customers, citizens and residents in Dubai, who are above the legal age and medically fit, are eligible to apply for this service.

- **Required documents:**

Original Emirates ID

- **For residents with visas issued in the other emirates, one of the following:**
 - Copy of the tenancy agreement approved by Ejari or copy of the Title Deed as a proof of residence
 - Copy of the company's trade license (Dubai branch and the branch that issued the residency) C Letter from the company certifying that the customer works in Dubai
 - An official document proving that you are currently a student in Dubai.
- **For diplomats**
 - Copy of the diplomatic passport
 - Original Emirates ID, if any
 - A copy of the valid diplomatic card for embassies, consulates and international organizations instead of the Emirates ID
 - A copy of a letter from the Ministry of Foreign Affairs valid for at least 6 months from the date of submission.
- **For People of Determination**
 - Copy of the certificate of transfer to the doctor issued by the Licensing Agency
*Note: The customer should refer to Rashid Hospital for the medical test.
- **For the Emirati passport holder who is without a family book (Marsoom holders)**
 - Copy of the valid passport
 - Copy of the valid Marsoom
- **For the Emirati passport holder who is the son of an Emirati woman**
 - Copy of the valid passport
 - Valid letter from the General Directorate of Residency and Foreigners Affairs stating that the customer's mother is Emirati
- **From golden residency holders who have a driver license from their countries**
 - A copy of the customer previous valid driving license
 - Knowledge test and Road test results.

 - Customers under 21 years old: 1 year

A new driving license.

- **Terms and conditions:**

- The customer must be present in person.
- The customer must be medically fit.
- Driving License categories available for POD are determined based on the medical report.
- The customer agrees to the terms and conditions when signing the training agreement and submitting the application through the DLS system.
- The training file is suspended if the customer doesn't take one of RTA tests (knowledge test, yard test, road test) within 6 months from his last appointment date.
- The customer must pass all the required tests to obtain the driving license.
- Once the customer passes the Road test, he receives a temporary license valid for 7 days through email.
- If less than two years have passed since the last appointment, the customer must reopen the learning file again to continue the application. If more than two years passed, the customer must apply again for the service.
- The customer must abide by the following conditions to apply for a learning permit:

- **Driving license for motorcycles**

The customer must not be younger than 17 years old.

- **Driving license for light vehicles**

The customer can open a traffic file after reaching the legal age of 17 years and 6 months. his license to be issued after he passes all the required tests and turns 18.

- **Driving license for vehicles that transport passengers**

Its weight while empty must not exceed 2.5 tons, and the number of passengers must not exceed 14 without the driver.

- **Driving license for vehicles that transport cargo**

Its weight while empty must not exceed 2.5 tons, and its cargo must not exceed 2 tons.

- **Driving license for heavy vehicles (all types of heavy and light vehicles)**

The customer must be 20 years old.

- **Driving license for light buses (all types of light buses and vehicles, which number of passengers do not exceed 26 without the driver)**

The customer must not be younger than 21 years old.

- **Driving license for heavy buses (all types of light and heavy buses and light vehicles)**

The customer must not be younger than 21 years old.

- **Driving license for tractors or light equipment (all types of tractors or light equipment, which weight while empty does not exceed 7.5 tons)**

The customer must not be younger than 20 years old.

- **Driving license for tractors or heavy equipment (all types of light and heavy tractors and equipment)**

The customer must not be younger than 20 years old.

- **Conditions related to the Eye Test**

- The customer must pass the eye test according to the requested category at an eye test center accredited by the Dubai Health Authority (DHA) and authorized by RTA.
- The eye test is valid for 2 years.

For drivers of light vehicles and motorcycles

- Right eye 6/18 -- Left eye 6/18
- Right eye 6/12-- Left eye 6/24
- Right eye 6/9 -- Left eye 6/36 or 6/60
- Right eye 6/6 -- Left eye blind.

For drivers of heavy vehicles with or without spectacles

- Right eye 6/6 -- Left eye 6/18 or 6/12 or 6/9
- Right eye 6/9 -- Left eye 6/9.

For the drivers of light and heavy buses, tractors and mechanical equipment with or without spectacles

- Both eyes must be 6/6 with or without spectacles.

For color blind customers

- The customer can apply for the permit on the condition of passing the eye test.

For holders of visas issued in other emirates

- The customer must not have a driving license file in another emirate.
- The activity and name on the trade license of the company's Dubai branch must correspond.
- The customer is exempt from presenting a trade license if he was a CEO of a company, institution, bank, public oil equipment company, university, or organization.

Apply for a New Driving License or a New Category Based on Exchanging Licenses

- **Eligibility:**

Residents are eligible to apply for this service.

- **Required documents:**

- **For customers with a residence visa issued in Dubai**
 - Valid Emirates ID
 - Electronic eye test
- **For customers with a residence visa issued in another emirate (the company has a branch in Dubai and the customer works there)**
 - Original valid Emirates ID
 - Electronic eye test
 - Trade license copy of both branches (Dubai and other Emirate branches)
 - Letter from the company certifying that the customer works in Dubai branch
- **For exchanging Singapore driving license**
 - Knowledge Test result
- **Diplomats**
 - Diplomatic passport + copy
 - Original driving license
 - Electronic eye test
 - Letter from the Ministry of Foreign Affairs valid for at least 6 months from the date of submission
 - Diplomatic card for embassies, consulates and international organizations instead of the Emirates ID.
- **Customers having a license from exception countries, but their nationality isn't from the listed countries**
 - Knowledge test result
 - Road test result.
- **Apply for Adding a New Category Based on Exchanging Licenses**
 - Original driving license from the exception countries + copy
 - Original valid Emirates ID
 - Electronic eye test
 - Letter from the Ministry of Foreign Affairs for diplomats
 - Legalized translation of the license (check the table in terms and conditions).

Apply for a New Driving License Based on Exchanging Licenses

- Diplomats must visit the Customer Happiness Centers to apply for the service to fulfill the requirements of their related exceptions.
- Driving licenses cannot be replaced for holders of dual passports if they were residents of an unauthorized country and it shows on one of their passports.
- Driving licenses issued from GCC for GCC citizens must be valid upon their replacement. Original licenses are withdrawn from their holders.
- GCC passport holders, who have a valid driver's license from the same country or from one of the exception countries, can exchange the driving license in Dubai regardless of the Emirates ID place of issuance.
- To exchange a Singapore driving license, the customer must take a Knowledge Test in one of the driving institutes mentioned in the 'ways to apply' list.

Apply for Adding a New Category Based on Exchanging Licenses

- Customers with a residence visa issued in other emirates can add a category to their driving license only if they live, study, or invest in Dubai.
- The customer must be present in person.
- If the visa was not issued in Dubai, the company must have a branch in Dubai, and the customer must work in Dubai branch.
- The customer must pass the eye test according to the requested category.

 - To transfer a driving license from another Emirate to Dubai
 - Original valid Emirates ID
 - Transfer letter from the other emirate
 - Electronic eye test
 - Medical fitness examination in case the profession of the customer was "driver" (the customer has to pass the comprehensive medical test at one of the accredited hospitals).
 - NOC to transfer a test file from Dubai to another Emirate
 - Proof of residence from the emirate that the customer wants to transfer his file to.
 - Original valid Emirates ID.
 - NOC to transfer a test file from another Emirate to Dubai
 - File transfer certificate from the licensing entity in the other emirate.
 - Electronic eye test.
 - Original valid Emirates ID.

- The customer must be present in person.

- The driving license is withdrawn when transferred.

- **To transfer a driving license from another emirate to Dubai**

- The customer must be present in person.

- If the customer has a traffic file, the license is transferred to the same file and the customer is exempted from the fees of opening the traffic file.

- If the customer does not have a traffic file, he must open a new file.

- The driving license must be valid at the time of transfer.

- If the customer has a visa from another emirate, and wants to transfer his driving license from the other emirate to Dubai, and if an NOC is required from RTA, he can apply for it in Dubai, free of charge, from any RTA Customer Happiness Centre or through RTA website provided that he works for a company that has a branch in Dubai under the same name stated in the trade license.

- **For NOC to transfer a test file from Dubai to another emirate or the opposite**

- If the customer failed his Road test in another emirate and wants to transfer his test file to Dubai, all his training data or internal tests completed in the other emirate are discarded, and he has to take 8 training classes then apply again for a Yard test and a Road test.
