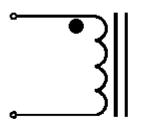


### **Schematic Diagram**
